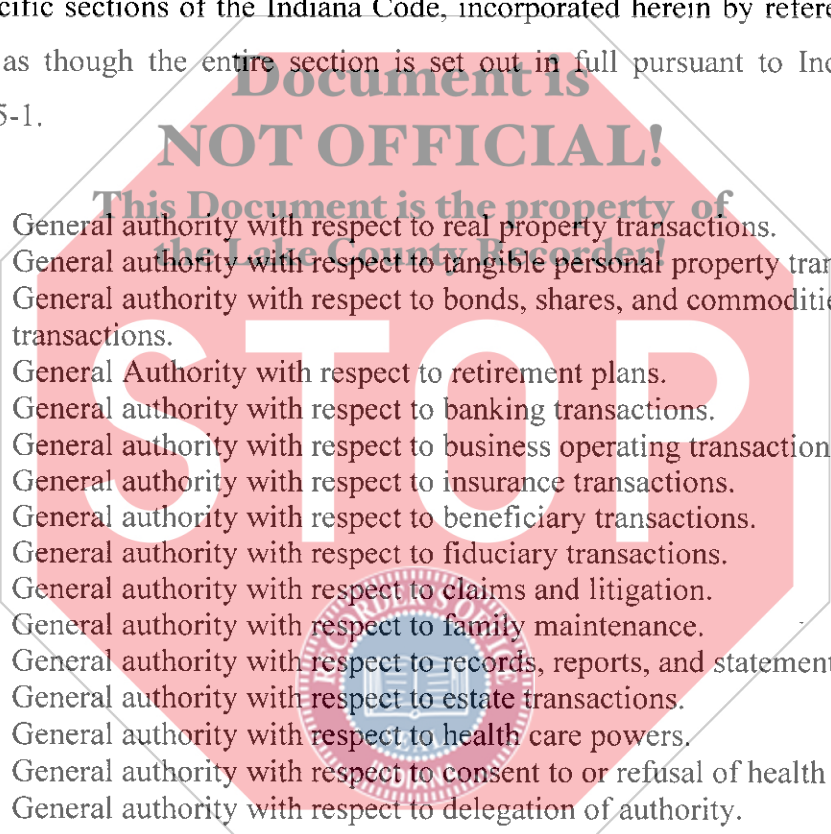

- § 30-5-5-17. General authority with respect to consent to or refusal of health care.

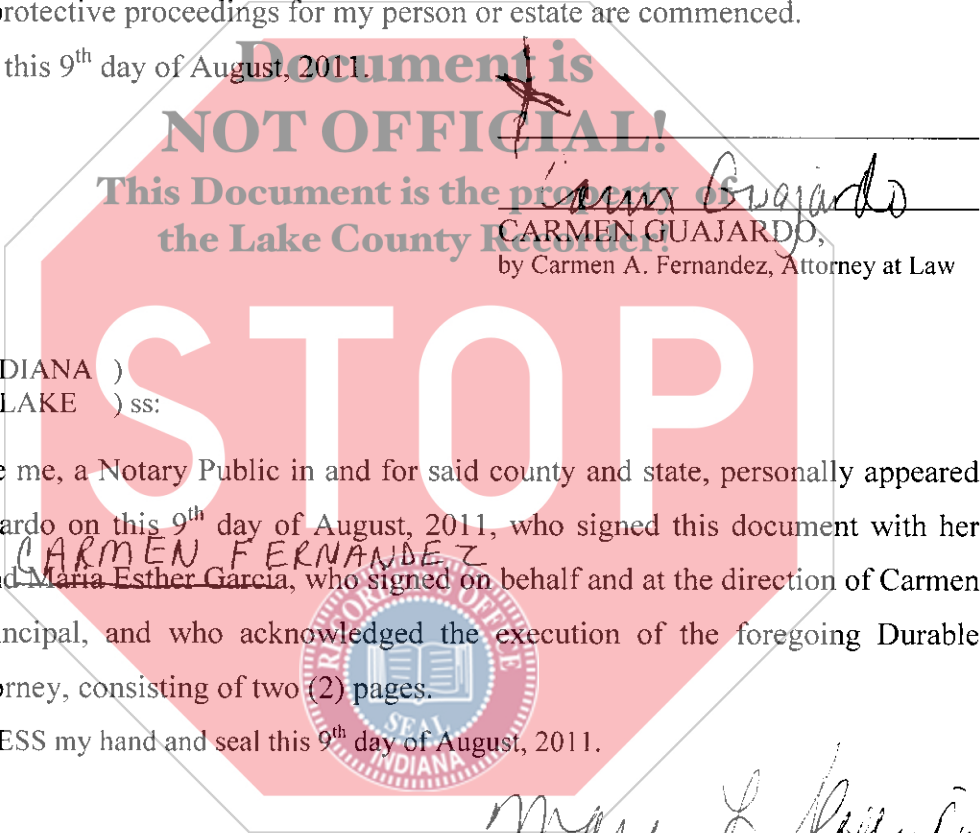


