THE CONDITION OF THE ABOVE OBLIGATION IS SUCH that whereas the said Principal has been granted a ELECTRICAL LICENSE

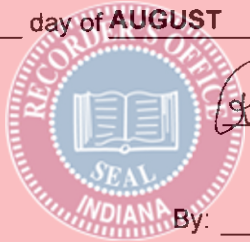
for a term beginning 08/05/2011 and ending 08/05/2012

POWER OF ATTORNEY

This appointment is made under and by the authority of a resolution which was passed by the Executive Committee of the Board of Directors of State Farm Fire and Casualty Company on the 8th day of June, 2009, as is duly authorized by the Board of Directors in Article II, Section 6 of the By-Laws of the Company, which resolution is:

WHEREAS, the Board desires to delegate the authority to appoint persons as Attorneys-in-Fact for certain bonds, undertakings, or other writings obligatory in the nature of a bond.
