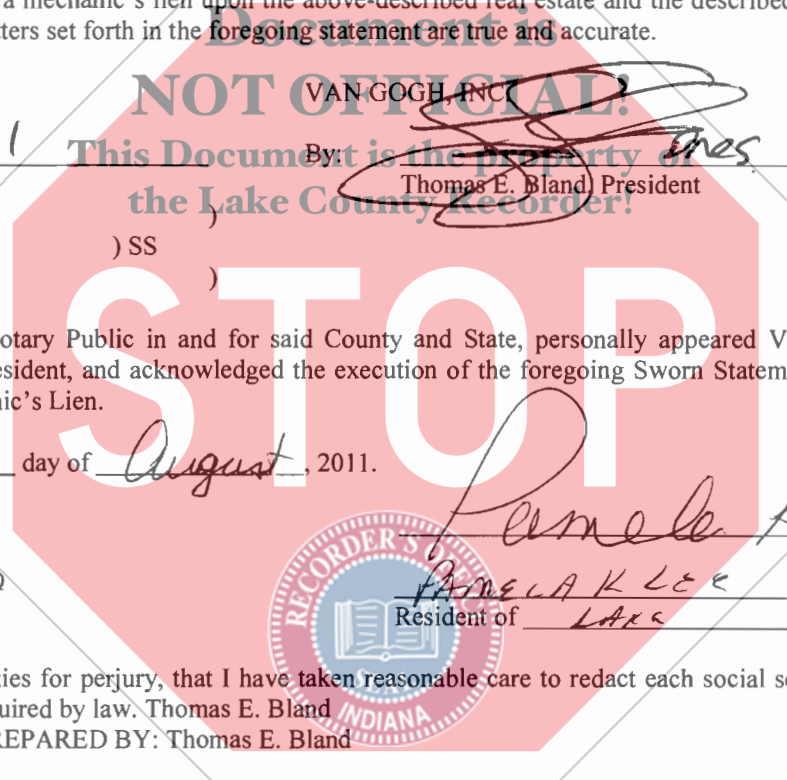
**SWORN STATEMENT AND NOTICE OF INTENTION TO HOLD MECHANIC'S LIEN**
