1. This obligation may be extended from year to year at the option of Surety, by Continuation Certificate executed by the Surety.
2. This obligation may be cancelled by the Surety upon giving (30) days written Notice to the Obligee. However, this obligation shall remain in full force and effect as to the acts or omissions of the above mentioned Principal prior to the cancellation of the bond.

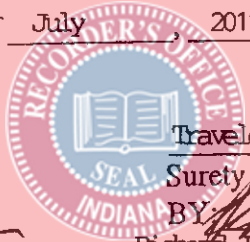

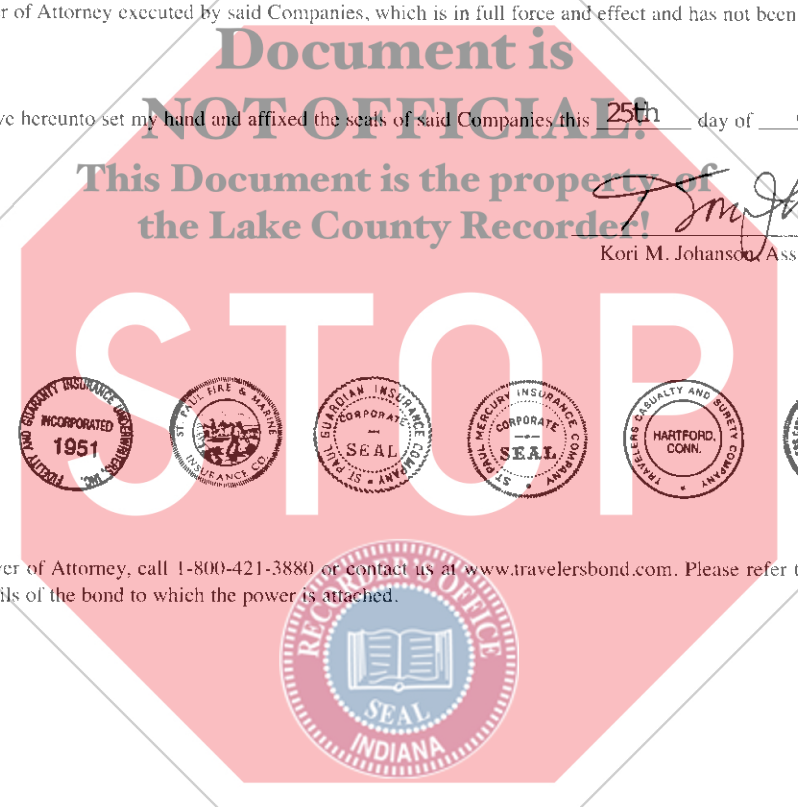
