Affidavit of Revocation and Termination of W-4 Forms

Dear Mrs. Vega,

I have to thank you for your help with the IRS last Month in July. The IRS only contacted you because I wouldn't give them my authority they requested, so the IRS used you as a last resort. They went to court and filed that Notice of Levy, and did other things that I won't mention.

I don't ever want them to use you again because of me, now with this document in your possession; I'm terminating all those W-4 forms that I've voluntary submitted and consented to on my own behalf.

Enclosed you will find the replacement forms which are the IRS form W-9 and the IRS W-8 BEN to have and to hold in your possession for all further and future use. It's up to me to make the IRS stop the garnishing, and using you for that will also stop.

I've changed my own status to Foreign instead of domestic, domicile or resident. If any complications occur with my instructions, we can work things out together in a cooperative manner in which I prefer to do first. If all else fails, court proceedings will assist us both with this endeavor. Those replacement forms that I've enclosed for this office to use in place of all those W-4 forms often go with IRS Forms 1099, and the IRS form 8109 B. How ever, those forms only reveal how your office is reporting taxes.

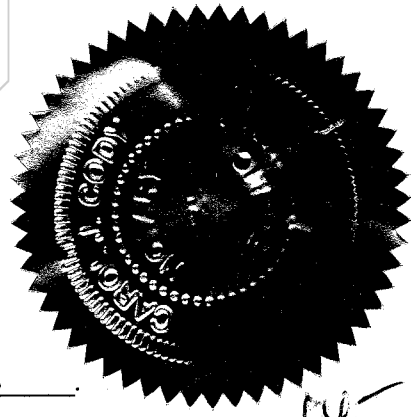

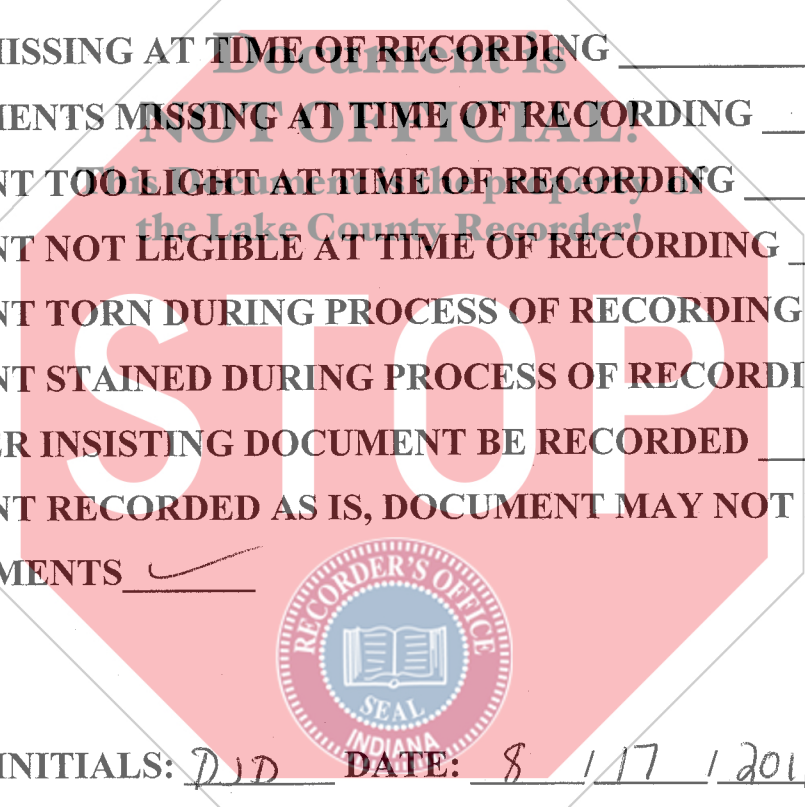
