subject to all covenants, restrictions, reservations, easements, conditions and rights appearing of record.

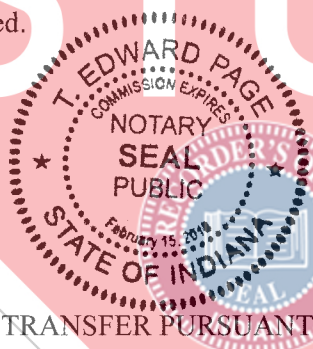
