Subject to taxes for 2011, due and payable in 2012, and taxes for all subsequent years, not yet due and payable.

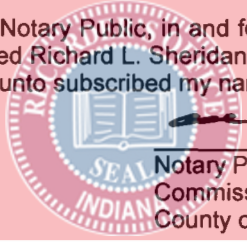

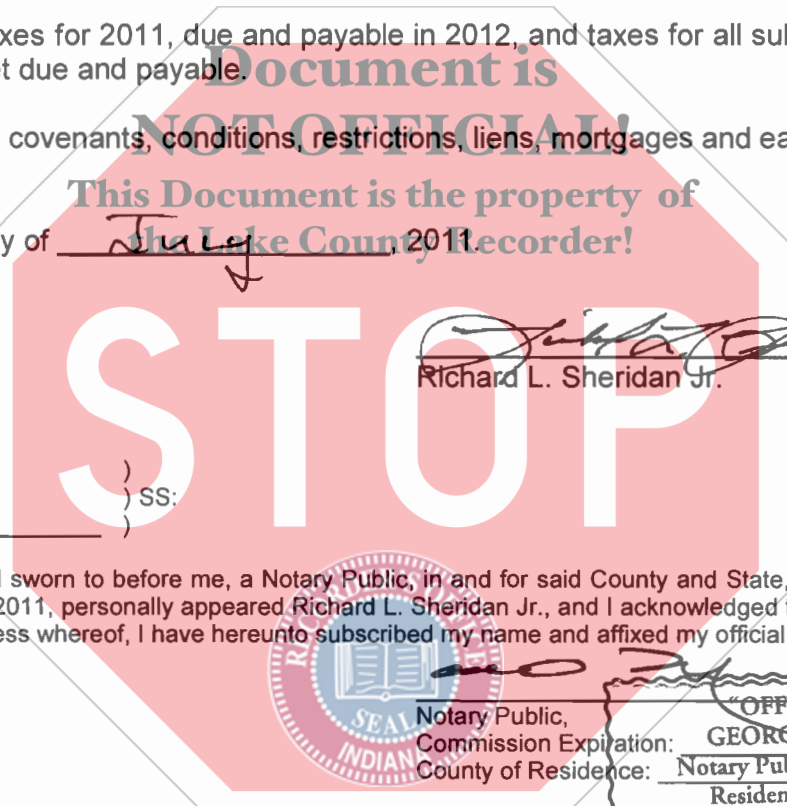
