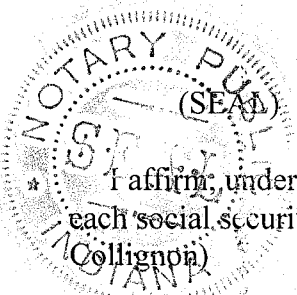

Parcel 1: Part of the Northwest Quarter of the Northwest Quarter of the Southeast Quarter of Section 5, Township 34 North, Range 8 West of the 2nd Principal Meridian, in the City of Crown Point, Lake County, Indiana, described as follows: Beginning at an iron pin North 5.0 feet and East 10.6 feet from the Southwest corner of said Quarter Quarter Section, which iron pin is on the right-of-way line of Main Street (State Road 55) and 30.0 feet from the centerline of said Street; thence East 148.0 feet to an iron pin; thence North 85.0 feet to an iron pipe on the Southerly right-of-way line of the P.C.C. and St. Louis Railroad; thence North 44 degrees 24 minutes West 211.5 feet, along said right-of-way line, to an iron pipe on the East right-of-way line of Main Street (State Road 55); thence South 236.0 feet along said line to the point of beginning.
