

MEMORANDUM OF LEASE

This Memorandum of Lease is hereby made and entered into on this the 18 day of August, 2011 by and between the HOUSING AUTHORITY OF THE CITY OF HAMMOND OF LAKE COUNTY, INDIANA, hereinafter referred to as "Landlord", and AMERICAN HEARTLAND HOMES TWO LLC, an Indiana limited liability company, hereinafter referred to as "Tenant";

WITNESSETH

WHEREAS, Landlord and Tenant have entered into and executed a certain Ground Lease of even date herewith ("Lease") whereby Landlord has agreed to lease to Tenant, and Tenant has agreed to lease from Landlord the certain tract or parcel of land lying and being in the City of Hammond, Lake County, Indiana, and all appurtenant rights and easements pertaining thereto, as more particularly described in Exhibit A, which is attached hereto and incorporated herein by this reference and hereinafter called the leased "Premises;" and, Document is

WHEREAS, Landlord and Tenant desire that notice of the existence of the Dease be contained in the public records for Lake County, Indiana.

Now, therefore, pursuant to the provisions of the Lease, Landlord and Tenant hereby acknowledge as he Lake County Recorder follows:

- Landlord has granted to Tenant a leasehold interest in the leased "Premises" for a Primary Term of commencing the date hereof and terminating on December 31, 2086.
- Tenant shall use the Premises for the construction and operation of buildings for dwelling units of 2 affordable housing.
- Tenant shall not assign or sublet all or any of the leased Premises or its interest in the Lease 3. without the prior written consent of the Landlord, except for residential leases having terms of not more than one year.
- Tenant shall have no right to encumber its leasehold interest in the 4. the advance written consent of the Landlord. AUG 2 2 2011
- The Lease Agreement shall be binding upon Landlord and Tenant, and their respective ONA, successors and assigns.
