3. The legal description of the Real Estate is as follows:

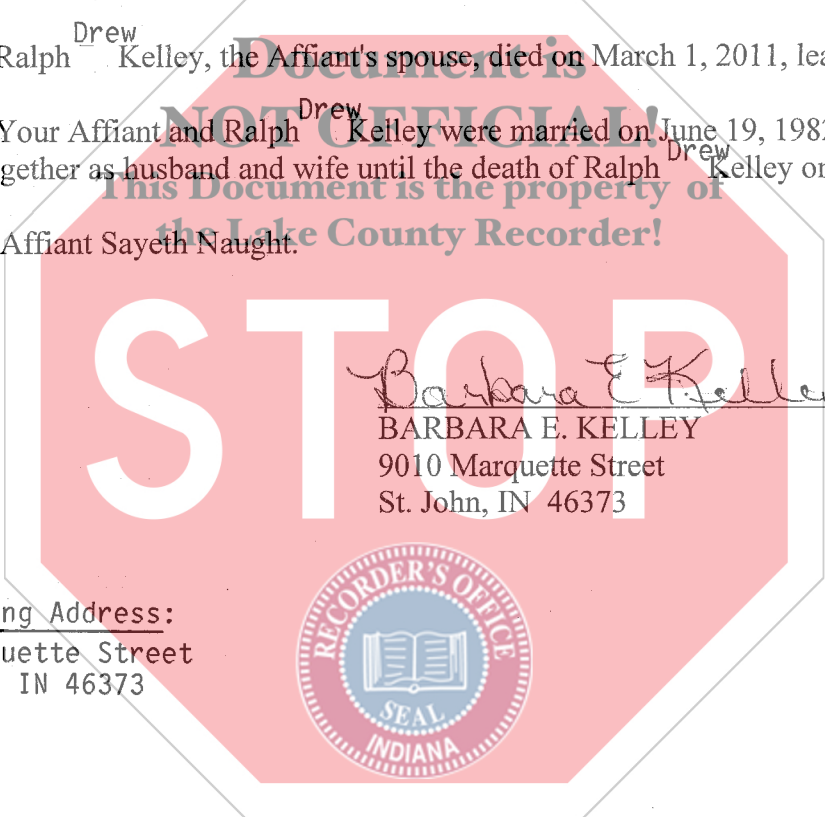
