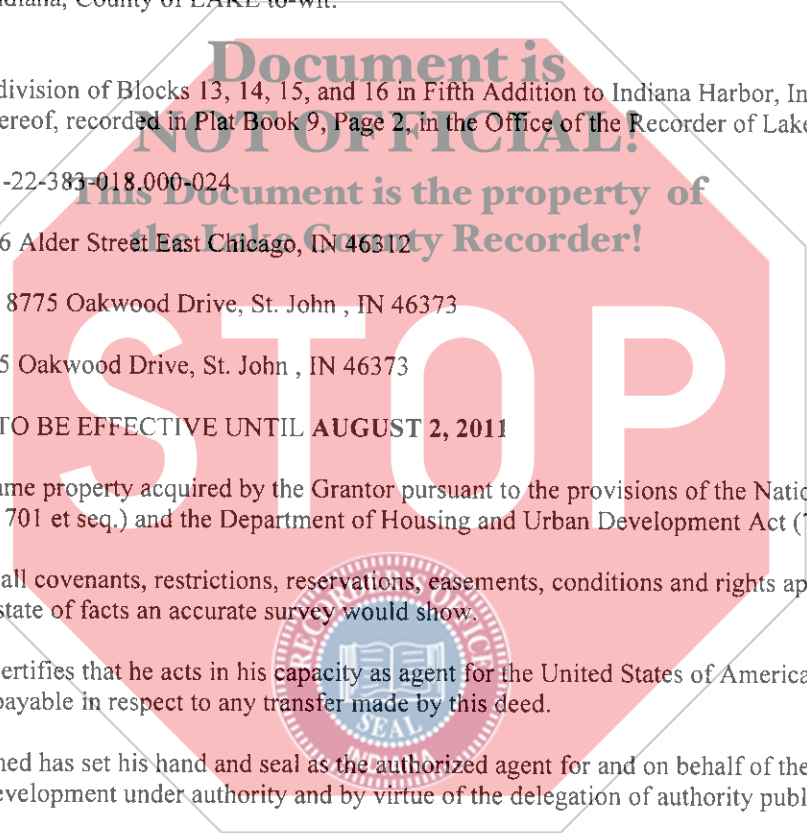
THIS DEED IS NOT TO BE EFFECTIVE UNTIL AUGUST 2, 2011

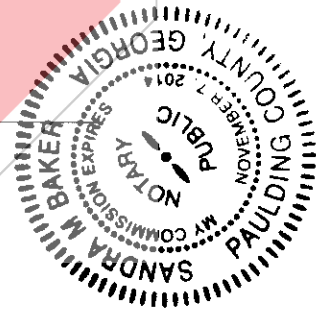
