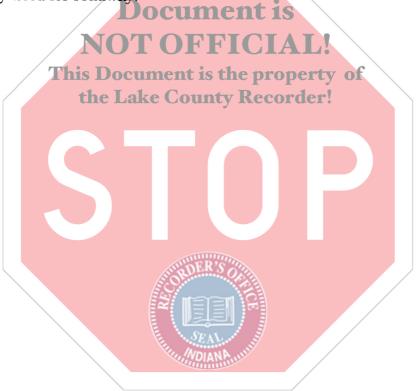

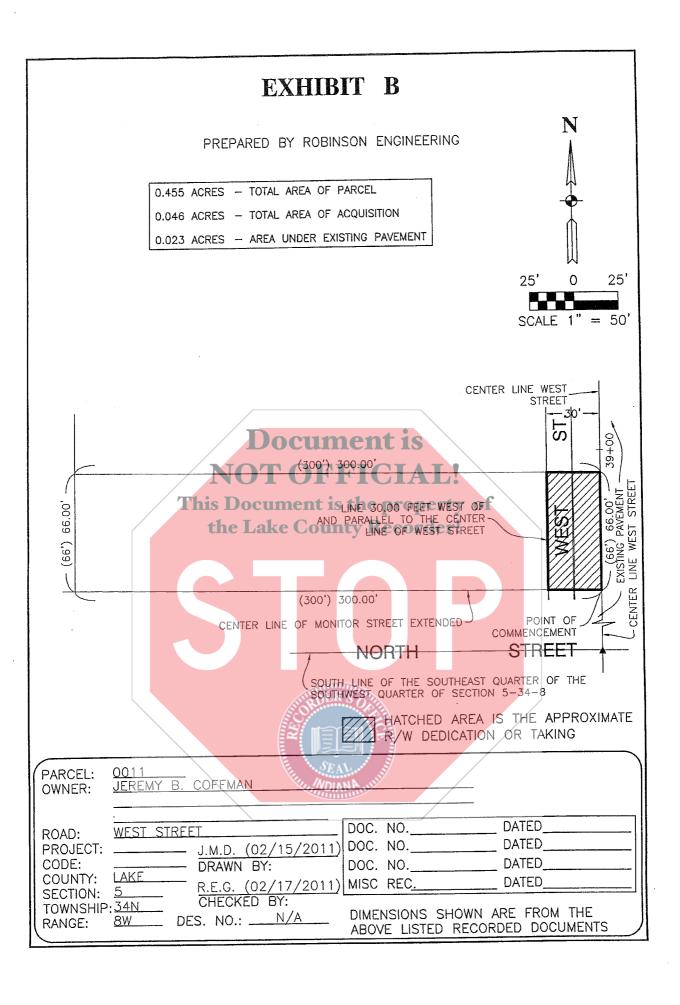
## LEGAL DESCRIPTION FOR ROADWAY ACQUISITION
