EXECUTRIX'S DEED

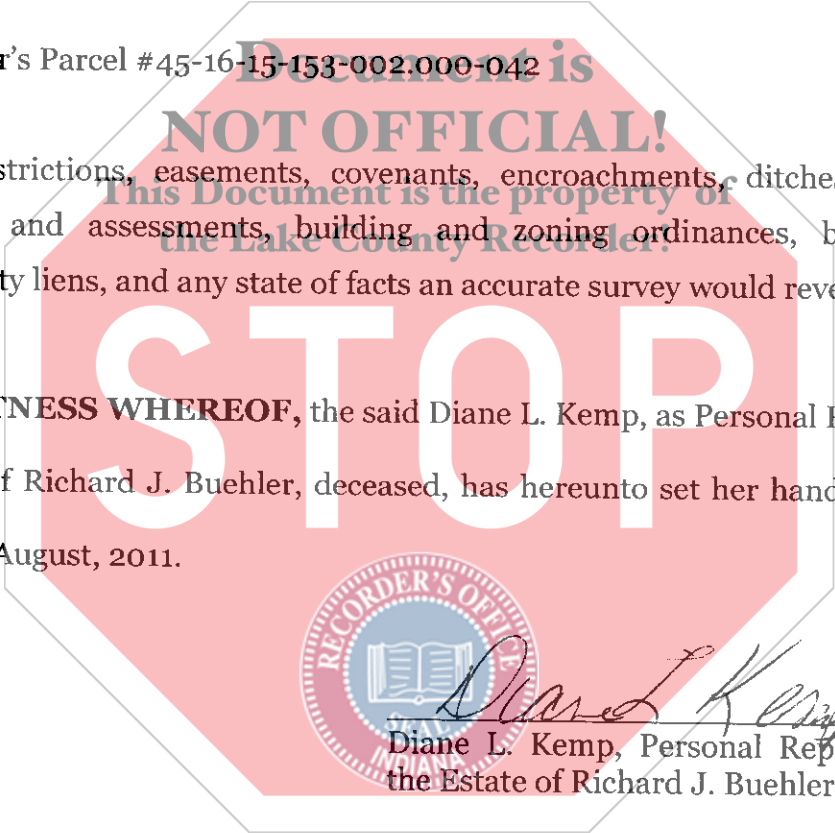

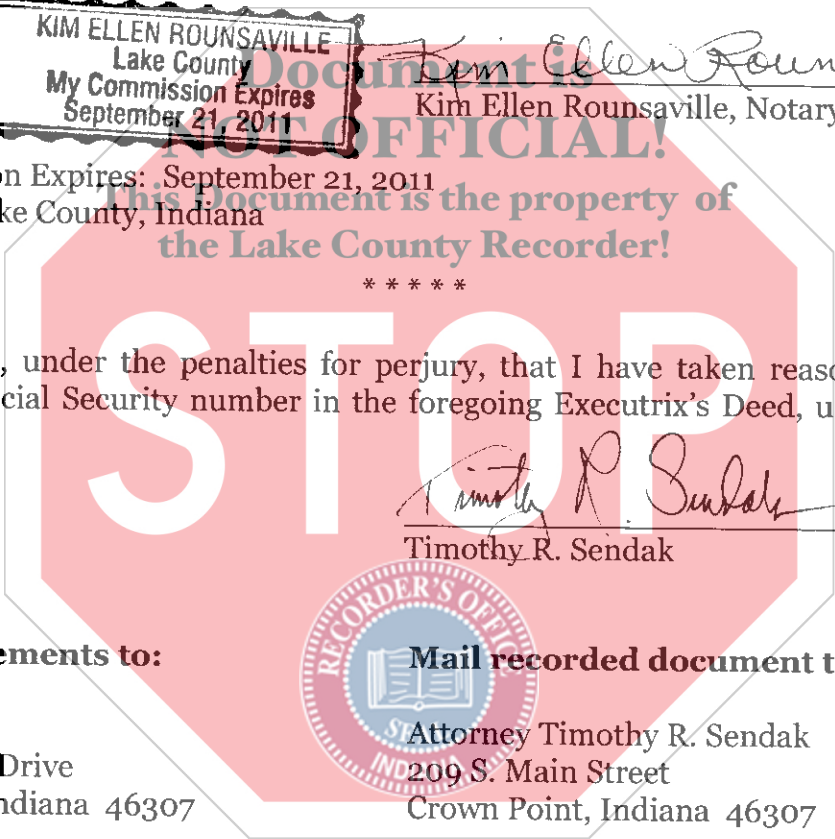
