
The condition of this obligation is such, that whereas, the principal has been licensed by the Obligee as Alarm Contractor

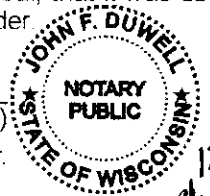

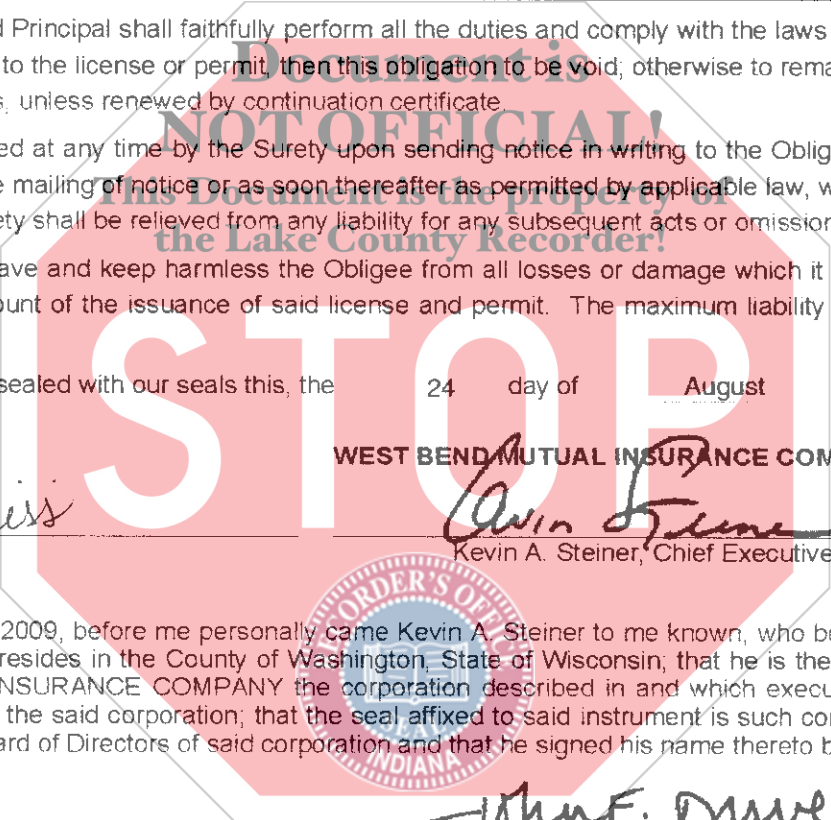
