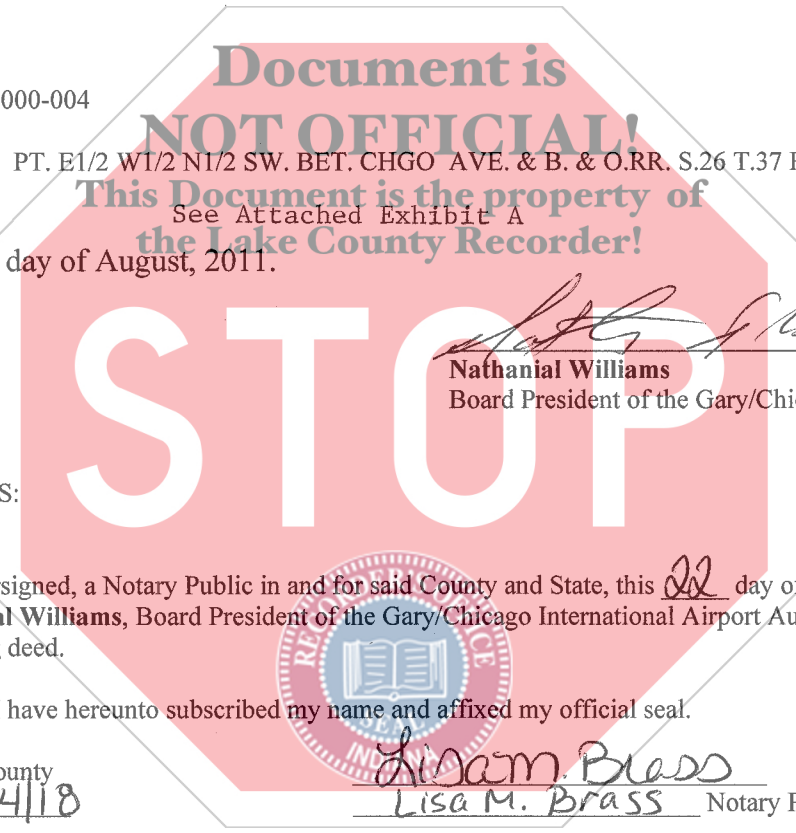

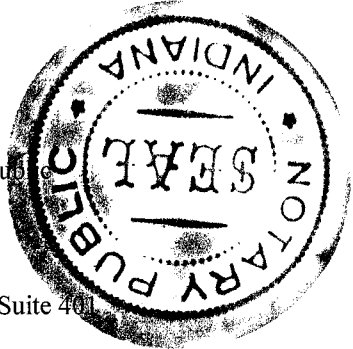

Parcel 1:

Part of the Southwest $\frac{1}{4}$ of Section 26, Township 37 North, Range 9 West of the 2nd Principal Meridian, described as follows: Beginning at a point on the South right-of-way line of the Baltimore & Ohio Chicago Terminal Railroad and 1026.73 feet East of the West line of the Southwest $\frac{1}{4}$ of said Section 26 (measured along said South right-of-way line), thence continuing East along said South right-of-way line 125 feet; thence South and parallel with the West line of the Southwest $\frac{1}{4}$ of said Section 26, a distance of 329.74 feet to a point 70 feet North of the center line of Chicago Avenue; thence West and parallel with the South right-of-way line of the Baltimore and Ohio Chicago Terminal Railroad 125 feet; thence North and parallel with the West line of the Southwest $\frac{1}{4}$ of said Section 26 a distance of 329.74 feet to the point of commencement, all in the City of Gary, in Lake County, Indiana.
