Subject to any and all current taxes and easements, agreements and restrictions of record. Tax bills should be sent to Grantee at address indicated below.

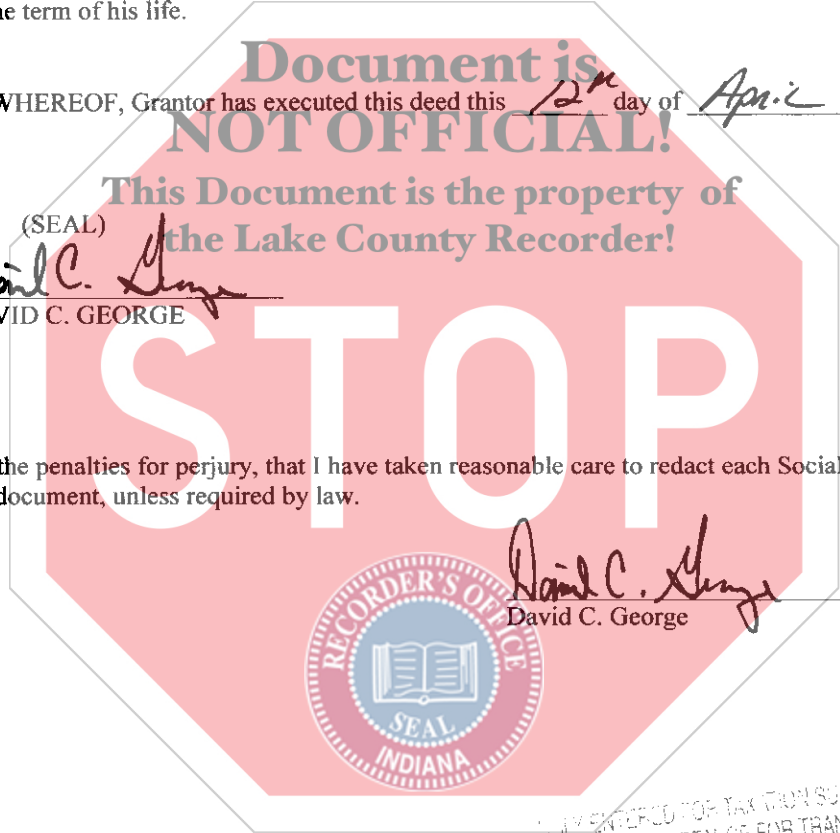
