1. On August 16, 2011, I Restated my Trust, known as the Matolin Living Trust, "Trust", which was originally executed on July 12, 1995.

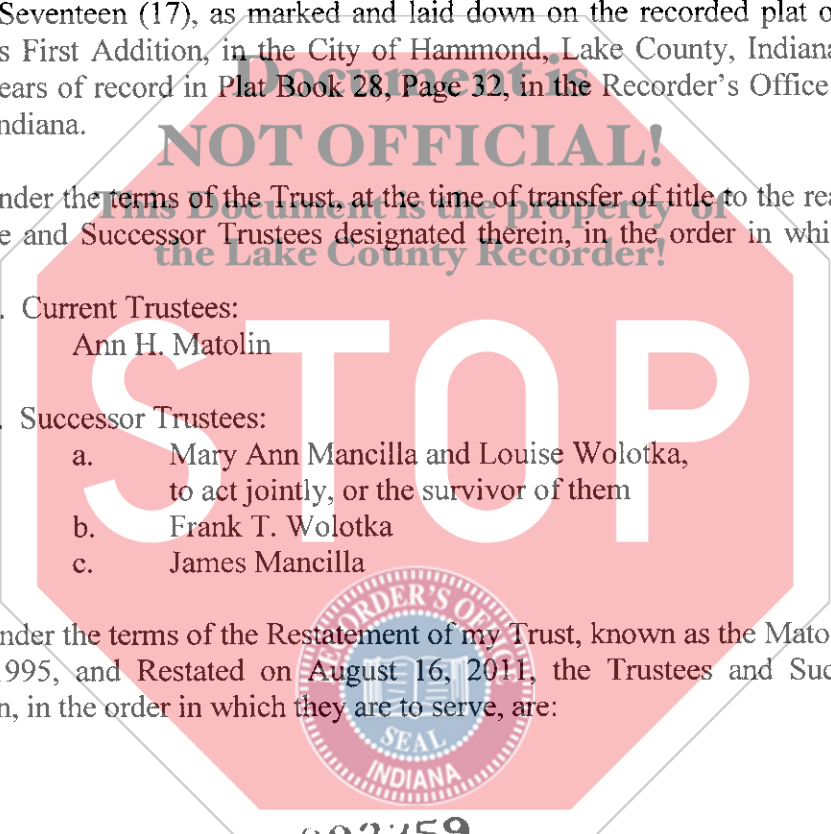
2. In reliance upon the terms and conditions of my original Trust, the following described real estate was transferred into the name of the Trustees of the Trust, to-wit:

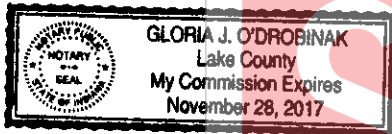
