LEGAL DESCRIPTION

Parcel 1: Part of Block 4, Cure's Grove Farm, as per plat thereof, recorded in Plat Book 25, page 26, in the Office of the Recorder of Lake County, Indiana, more particularly described as follows: Beginning at the Northwest corner of Block 5, Cure's Grove Farm, as per plat thereof, recorded in Plat Book 25, page 26; thence North 89 degrees 18 minutes 57 seconds West, along the North line of said Block 4, a distance of 124.30 feet; thence South 00 degrees 00 minutes 00 seconds East, parallel with the East line of Block 4, a distance of 400.00 feet; thence South 89 degrees 18 minutes 57 seconds East, parallel with the North line of Block 4, a distance of 400.00 feet to the East line of Block 4; thence North 00 degrees 00 minutes 00 seconds East, along said East line, a distance of 286.25 feet to the Southeast corner of Block 5; thence North 89 degrees 18 minutes 57 seconds West, a distance of 275.64 feet to the Southwest corner of Block 5; thence North 00 degrees 01 minute 49 seconds West, along the West line of Block 5, a distance of 113.75 feet to the point of beginning.
