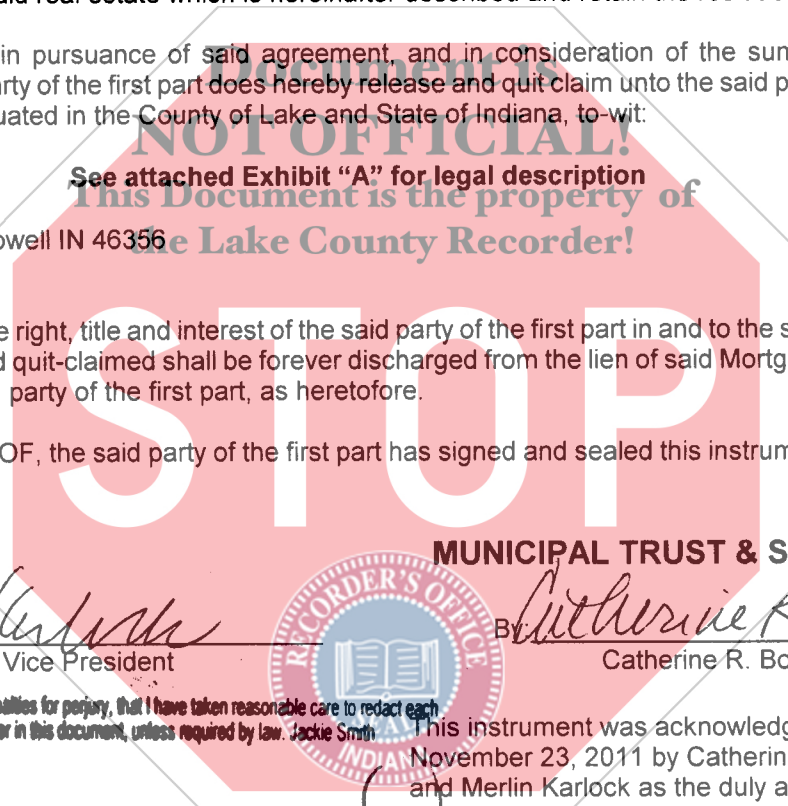


Exhibit "A"
