SPECIAL WARRANTY DEED

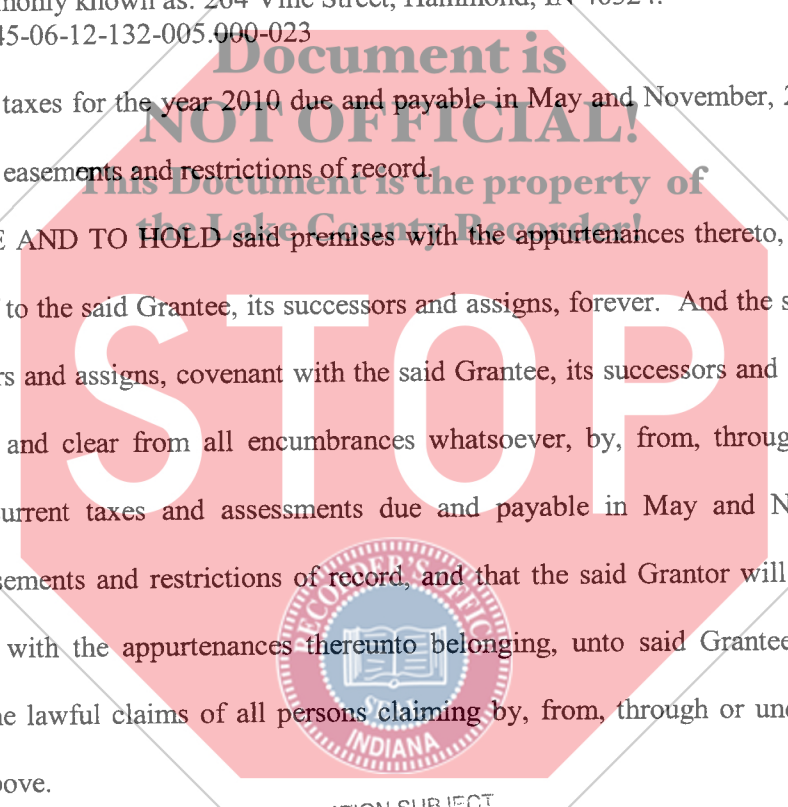

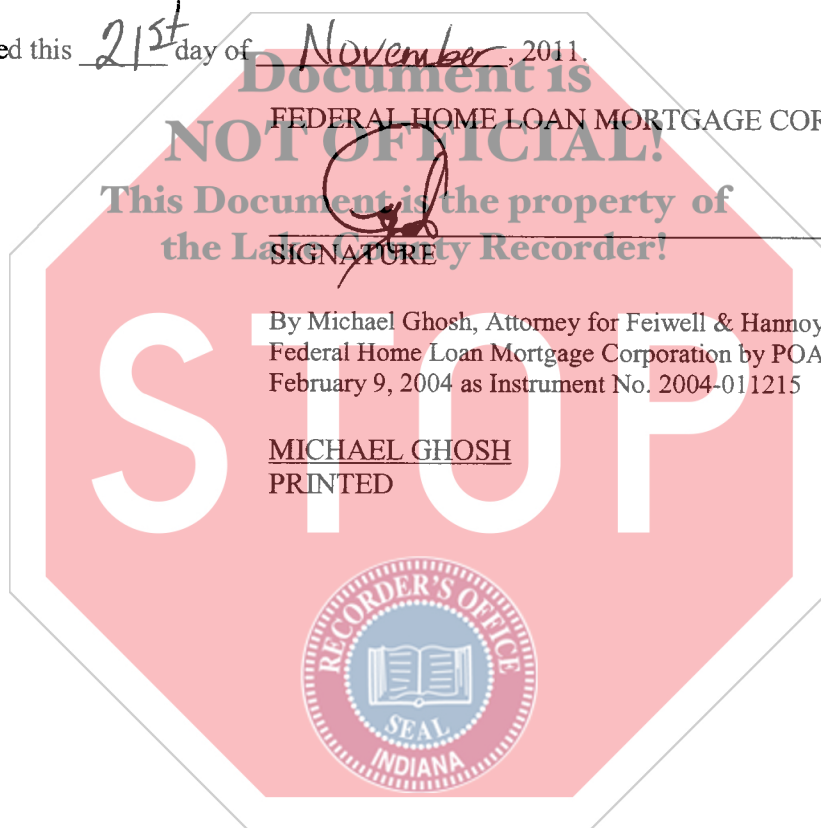

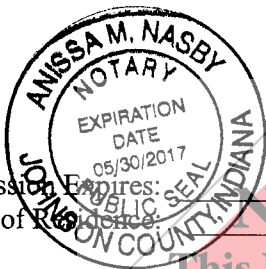
