Part of the East 1/2 of the Northwest 1/4 of Section 15, Township 35 North, Range 8 West of the 2nd P.M., described as follows, to-wit: Commencing at a point 138.55 feet South of the Southwest corner of Lot 12, Block 1 in Part No. 2 of Merrill Heights Subdivision, as the same appears of record in Plat Book 28, page 58, in the Recorder's Office of Lake County, Indiana, which point is 160 feet West of the West line of Delaware Street extended South; thence East on a line parallel with the South line of said Lot 12, Block 1 in Merrill Heights Subdivision, (said being identical with the North line of Pierce Street) a distance of 160 feet to a point on the West line of Delaware Street extended South; thence South on said West line thereof, a distance of 78 feet; thence West on a line parallel with the South line of said Lot 12, Block 1, a distance of 160 feet; thence North 78 feet to the place of beginning in Lake County, Indiana
