PROVIDED, HOWEVER, That this bond shall continue in force until:

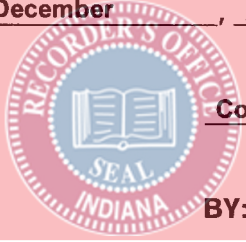
1. December 6, 2012, or until the expiration date of any Continuation Certificate executed by Surety, at its sole option.

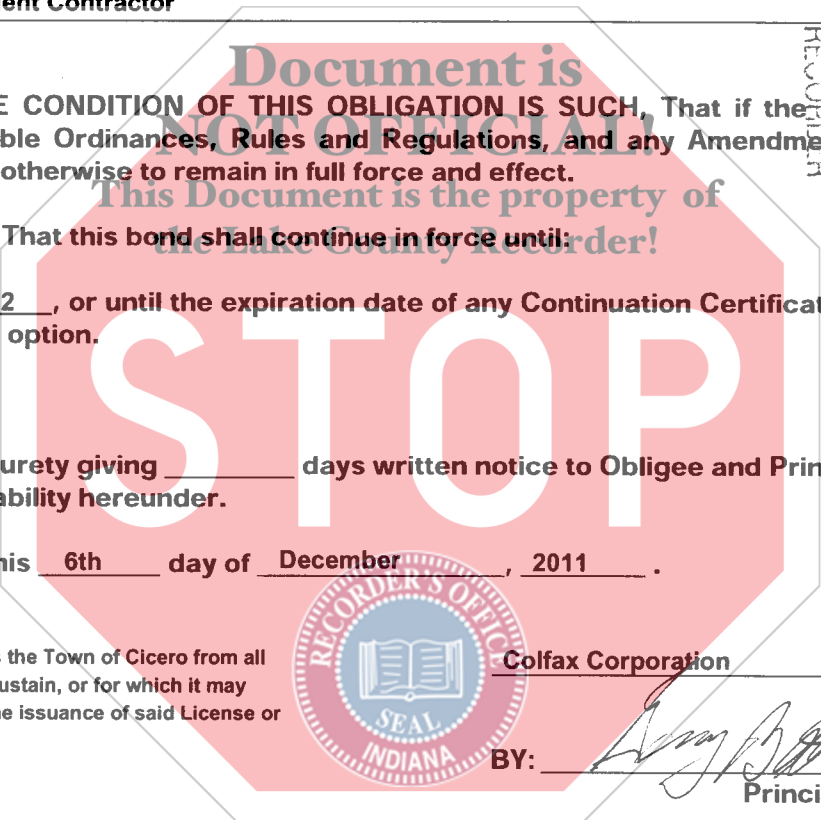

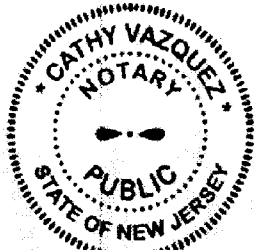
