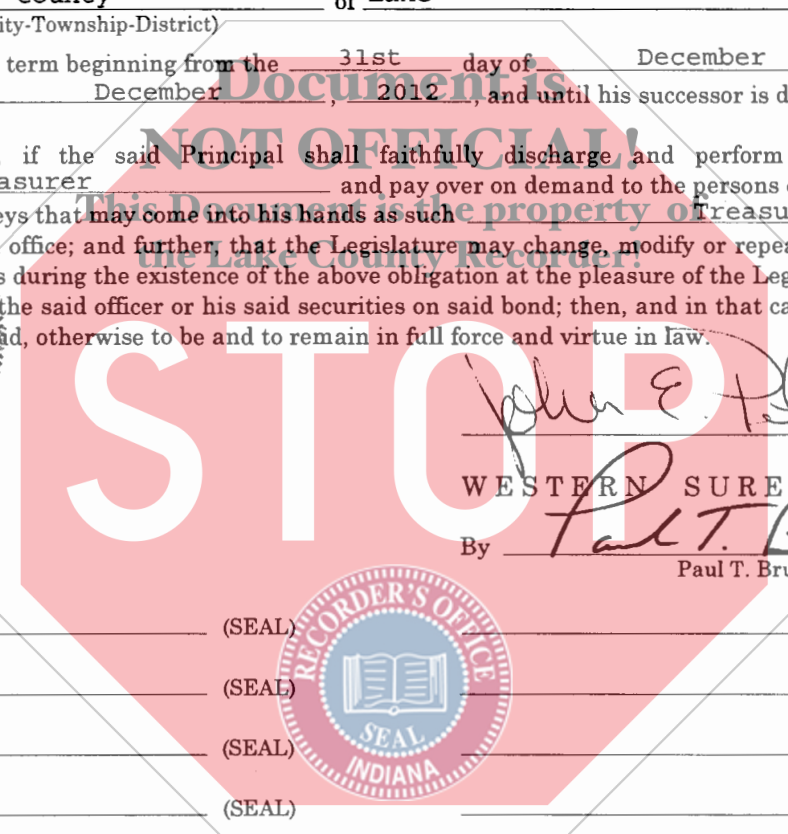
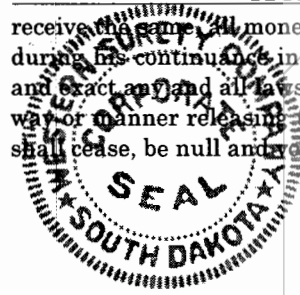
That we, John E. Petalas,

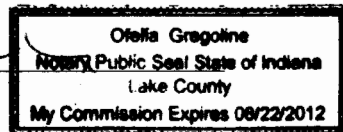

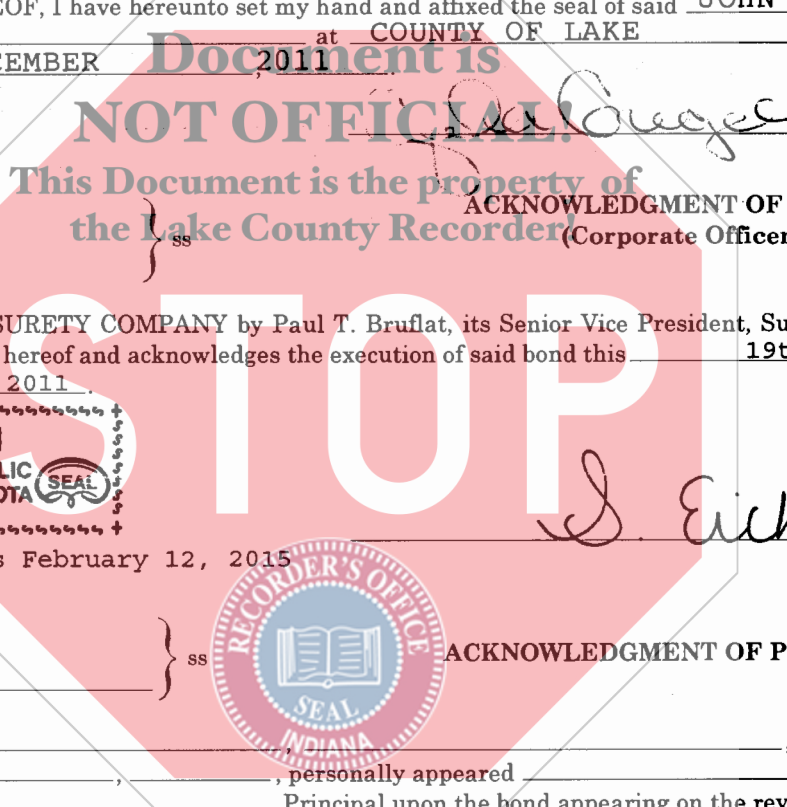

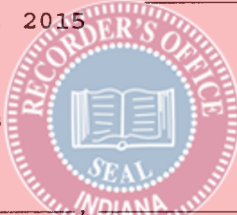
