Subject to taxes for the year 2011, due and payable in 2010, and taxes for all subsequent years.

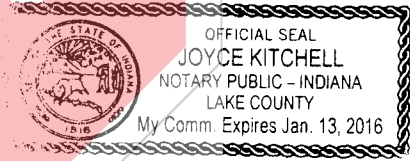


