CONFIRMATORY RESOLUTION
NO. 314

WHEREAS, the Board of Trustees of the Town of Dyer, Lake County, Indiana, did on the 12th day of August, 1955, adopt Declaratory Resolution No. 313 for the vacating of a portion of an alley in the Town of Dyer, more particularly described as follows, *a street and*
to-wit:

All that part of Fagen Street (60 feet in width) lying North of and adjacent to Lots Eight (8) to Thirteen (13) both inclusive, in Block Fifteen (15) in Hart's Addition to the Town of Dyer, Lake County, Indiana, and that part of the North and South Alley (16 1/2 feet in width) lying between Lots Nine (9) and Eleven (11) both inclusive, in Block Thirteen (13) in Hart's Addition to the Town of Dyer, Lake County, Indiana.

WHEREAS, the said Board of Trustees of said Town of Dyer, Lake County, Indiana, fixed the 9th day of September, 1955, at 8:00 o'clock P. M. of said day as the time for hearing remonstrances as published in the Hammond Times and Lake County Globe Ledger, both being newspapers of general circulation printed and published in the English language in Lake County, Indiana, (there being no newspaper in the said Town of Dyer) on the 25th day of August, 1955, as shown by the affidavit of the publishers of said newspapers now on file in the office of the Clerk Treasurer of the said Town of Dyer, Lake County, Indiana, and posted in each ward of said Town of Dyer, on the 25th day of August, 1955, in the following places:

Dyer Post Office
Dyer Town Hall

all as shown by the affidavit of the Marshall of the Town of Dyer, now in the office of the Clerk-Treasurer of said Town of Dyer, Lake County, Indiana.

WHEREAS, no written or oral remonstrances were received or filed with said Board and no person or persons have made written

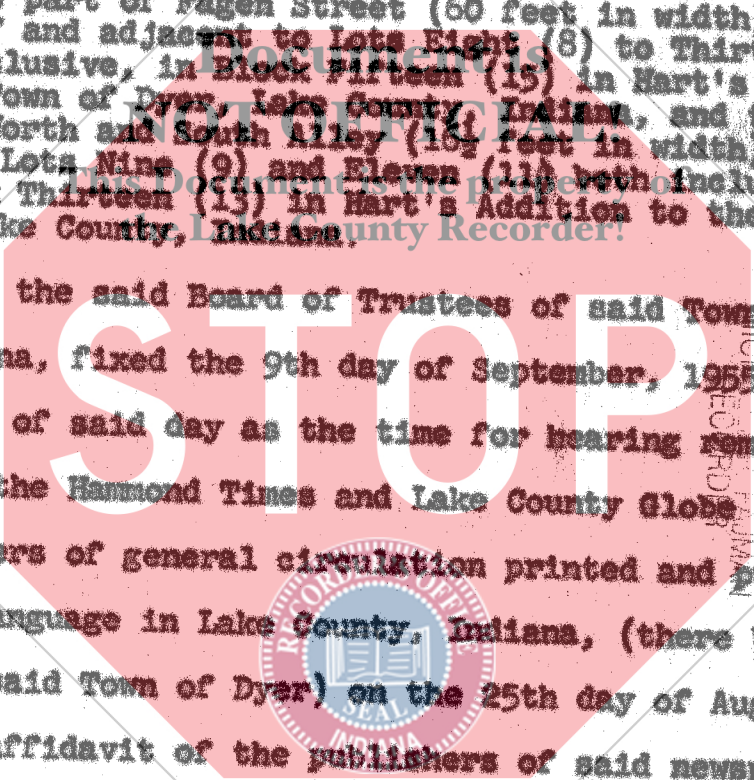
