SPECIAL WARRANTY DEED

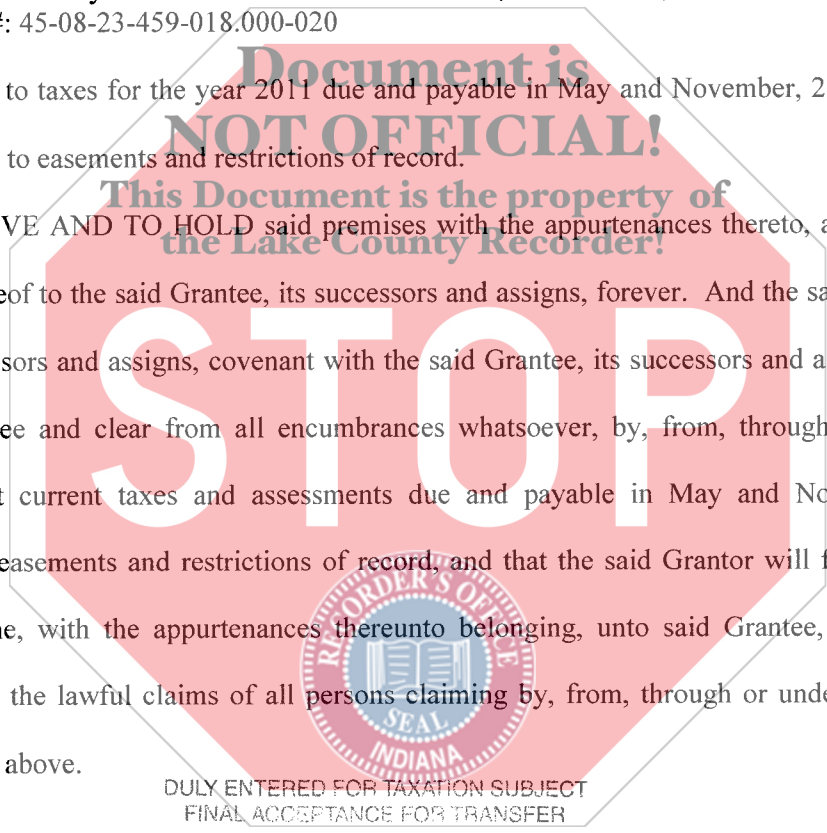

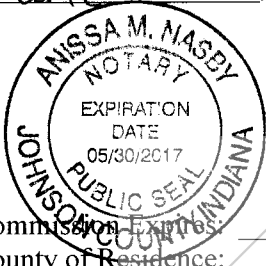
