- 2. That MIKE A. EVANYO and BARBARA F. EVANYO, Husband and Wife, took title to the following described real estate, to-wit:

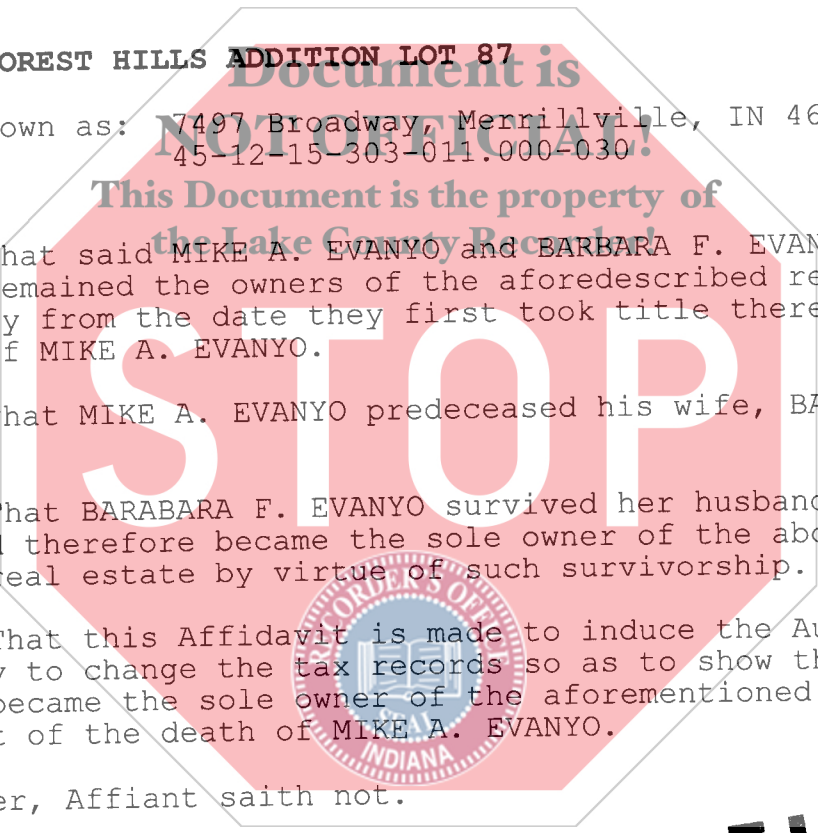
