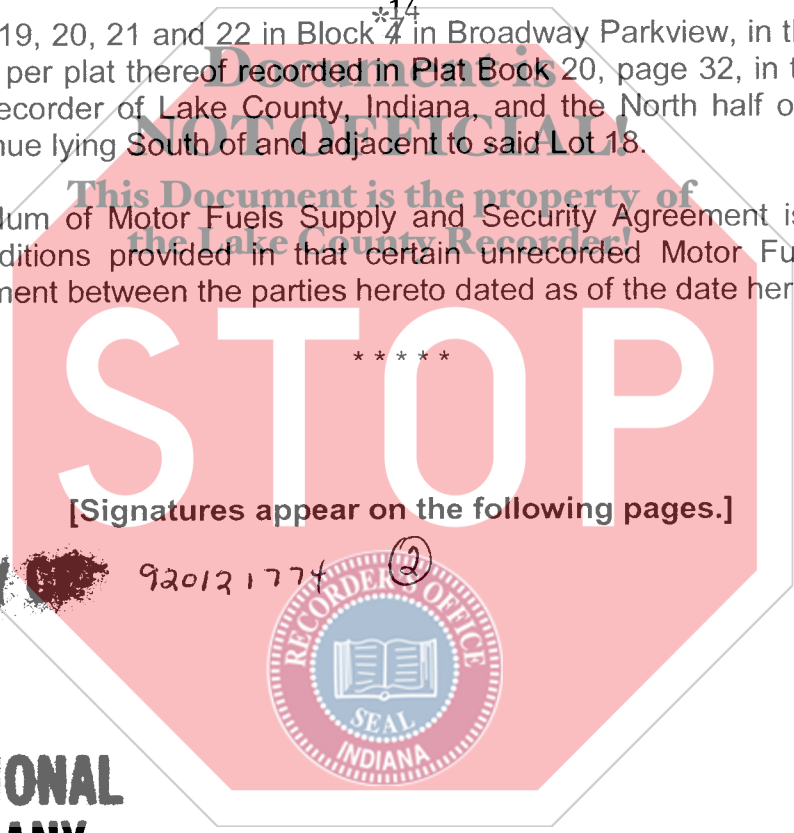
## MEMORANDUM OF MOTOR FUELS SUPPLY AND SECURITY AGREEMENT



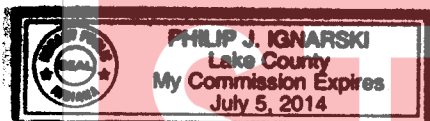
