WHEREAS, the Principal has obtained or is about to obtain a license or permit for Specialty Contractor-Industrial Painting and Tank Lining

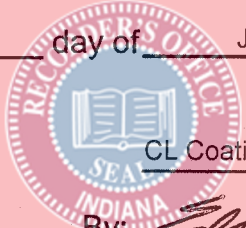
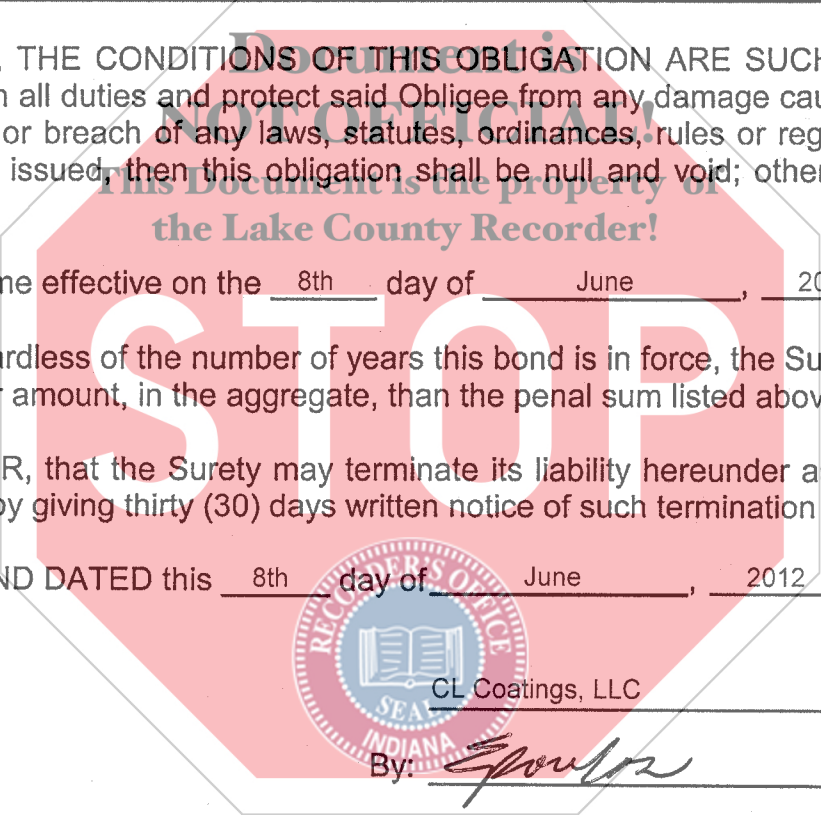
