The Mortgage does not state a time or date by which the debt or the last installment thereof secured by the Mortgage (the "Secured Obligation") becomes due.

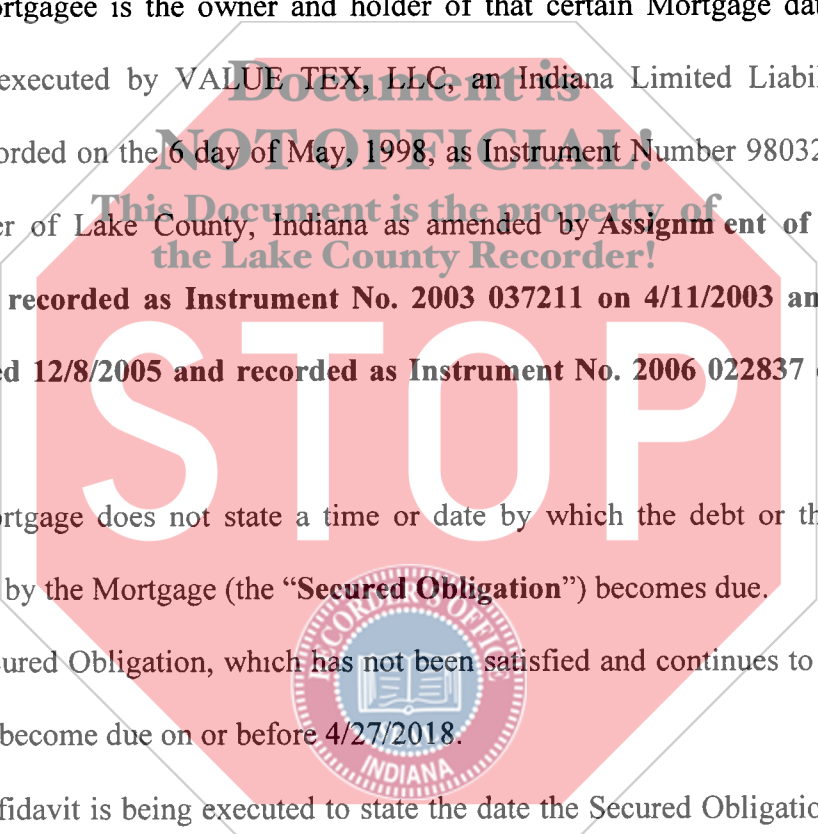
The Secured Obligation, which has not been satisfied and continues to be secured by the Mortgage, will become due on or before 4/27/2018.



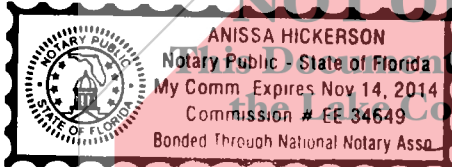


