**AFFIDAVIT STATING WHEN MORTGAGE DEBT BECOMES DUE**

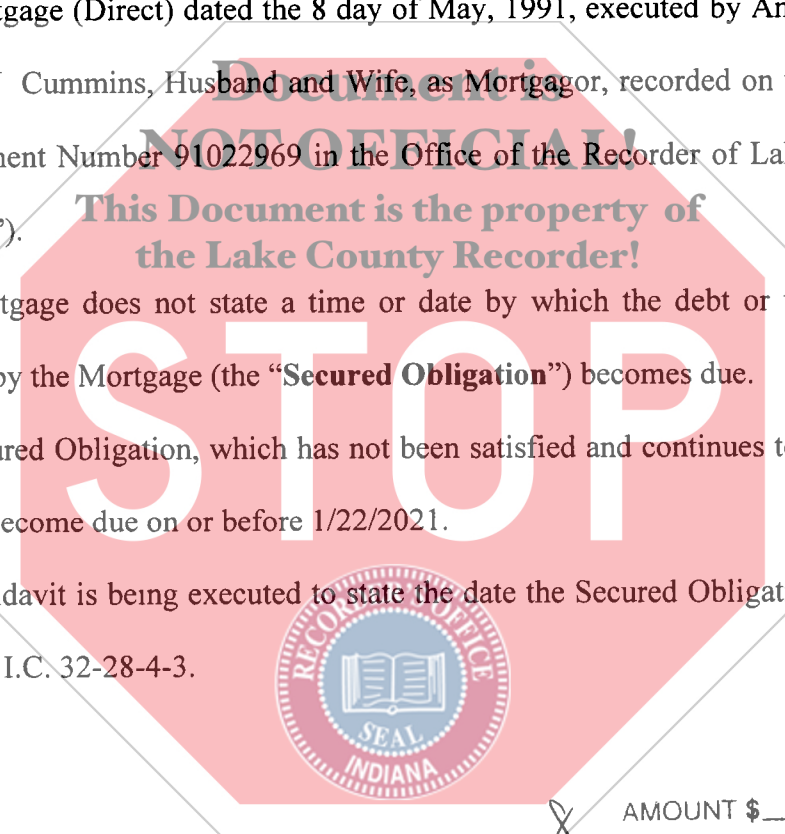
