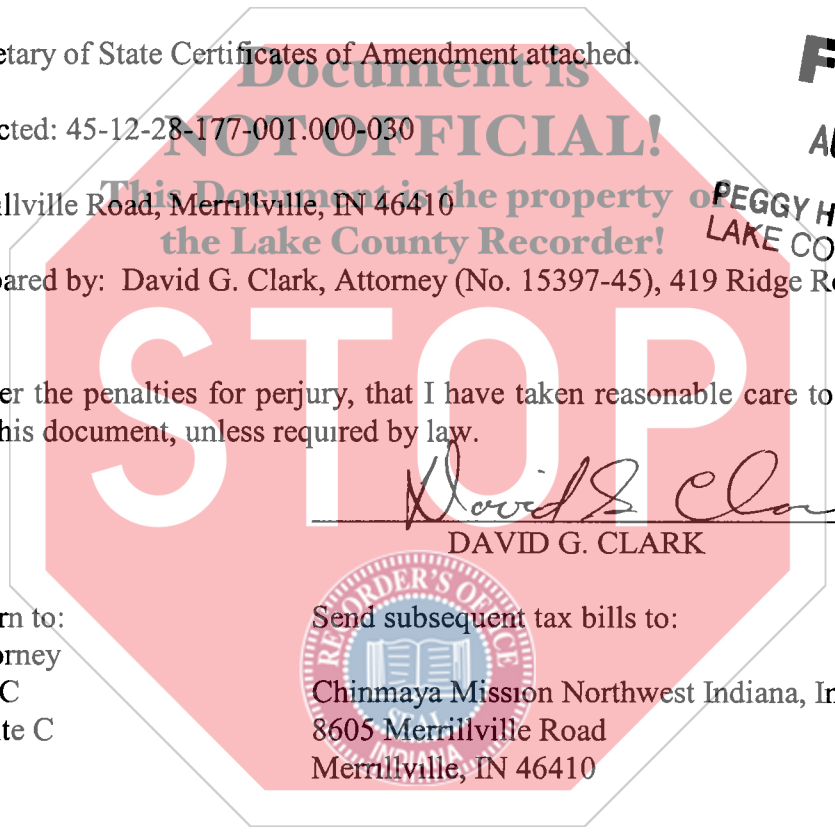

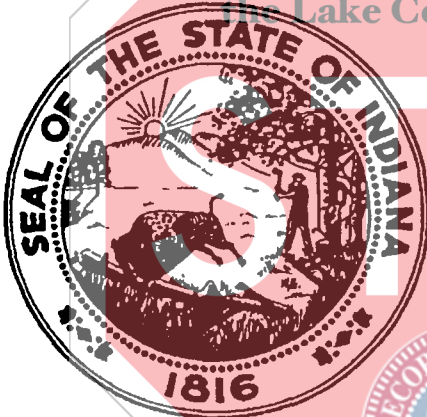



LEGAL DESCRIPTION

Part of Lot 1 in Broadwest Center to the Town of Merrillville as recorded in Plat Book 72 page 84, in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: Beginning at a 5/8's-inch iron Bar with Sayers I.D. Cap at the Northwest corner of Deerfield Center, an Addition to the Town of Merrillville recorded in Plat Book 79 page 69, in the Office of the Recorder of Lake County, Indiana, thence South 00 degrees 01 minutes 55 seconds West, along the West line of said Deerfield Center, a distance of 200.00 feet, to a 5/8's-inch iron bar with Sayers I.D. cap; thence North 89 degrees 09 minutes 34 seconds West, along the South line of said Lot 1, a distance of 309.55 feet, to a 5/8's-inch bar with Sayers I.D. Cap on the Easterly right-of-way line of Merrillville Road (80 feet wide right-of-way); thence North 23 degrees 03 minutes 01 seconds East (North 23 degrees 06 minutes 53 seconds, platted), along the said Easterly right-of-way, being the Westerly line of said Lot 1, a distance of 216.01 feet (216.10 feet, platted), to a 5/8's-inch iron bar with Sayers I D cap at the Northwest corner of said Lot 1; thence South 89 degrees 09 minutes 34 seconds East, along the North line of said Lot 1, a distance of 225 08 feet; to the point of beginning.
