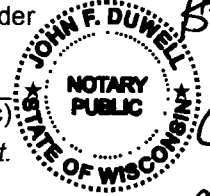

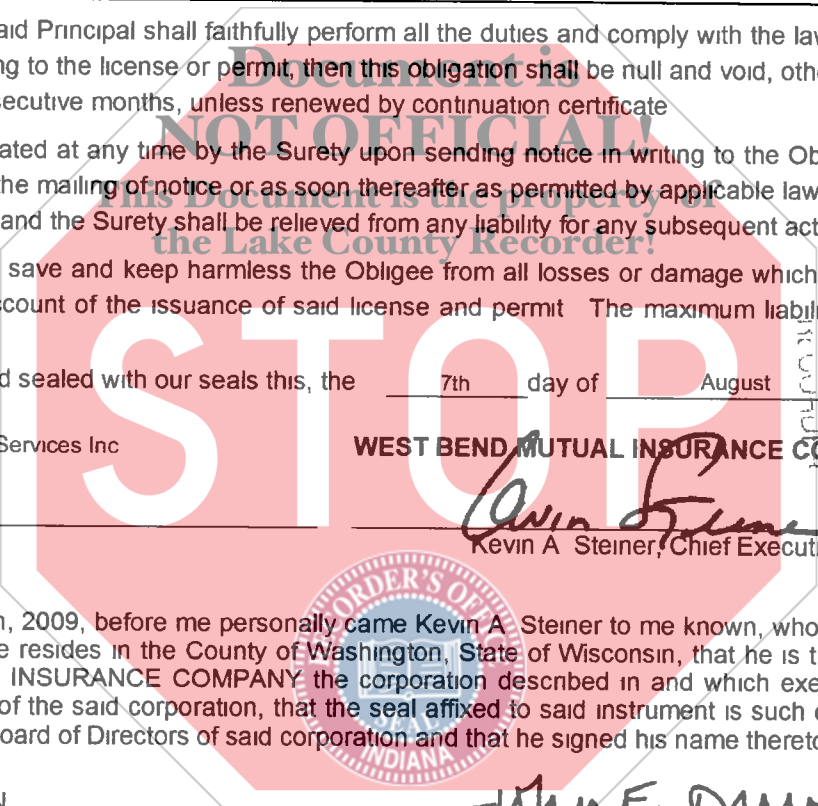



### Power of Attorney



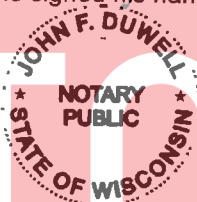


