MEMORANDUM OF CONTRACT

In the event that the OWNER shall sell, transfer or refinance the property during the Affordability Period, then the Department of Community Development shall be entitled to the return of funds paid for repair of the property, on a pro rata basis. The Department shall have a lien on the property in the contract amount.
- 3. The Contract contains other agreements and covenants of the parties, as set forth in an executed counterpart of it in possession of the parties.
