The Indigenous National Yishmael Yisrael El is an Indigenous National of the International Indigenous Society (ISIS) and Aboriginal Republic of North America Government, an Indigenous Government operating an Indigenous Plebiscite which has been noticed to and confirmed by the United States Department of States (Federal Authentication # 060131441) signed by Secretary of State Condoleezza Rice and in conformity with 22 CFR 131 1 & 131 2, USC Title 4 section 42 and is protected/governed by International Law United Nations Declaration on the Rights of Indigenous Peoples (Article 4) – Self Autonomy Government

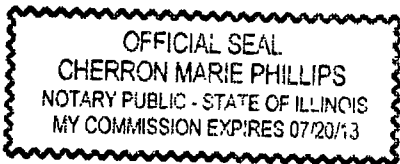
