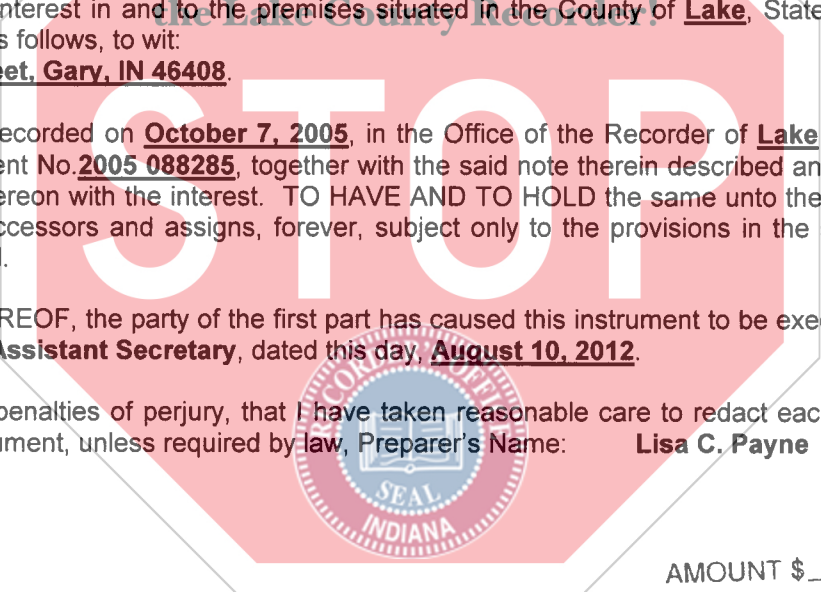
Indiana Assignment of Mortgage

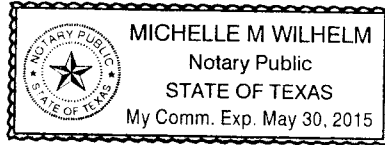
