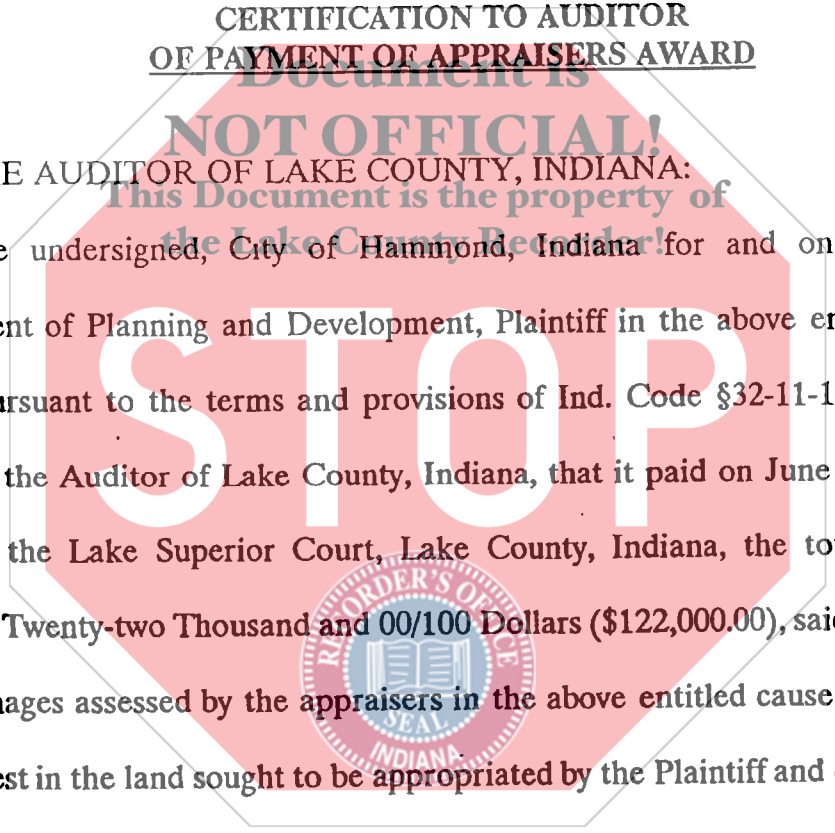

A parcel of land lying in Block 2, Robertsdale Industrial Park, to the City of Hammond, as shown in Plat Book 54, Page 35, in the Office of the Recorder of Lake County, Indiana, more particularly described as follows: Beginning at the Southeast corner of said Block 2; thence South 89 degrees 13 minutes 17 seconds West, along the South line of said Block 2 (North right-of-way of 126th Street), a distance of 147.84 Feet; thence North 00 degrees 46 minutes 03 seconds West, parallel to and 294.68 Feet East of the West line of said Block 2 (Easterly right-of-way of Gaspar Avenue), a distance of 339.26 Feet; thence North 89 degrees 13 minutes 17 seconds East, parallel to the South line of said Block 2, a distance of 152.21 feet, to a point on the East line of said Block 2; thence South 00 degrees 01 minutes 42 seconds East, along said East line, a distance of 339.39 feet to the point of beginning, all in the City of Hammond, Lake County, Indiana (all of which is commonly referred to as the Northwest Corner of 126th and New York Avenue in the City of Hammond, Lake County, Indiana).

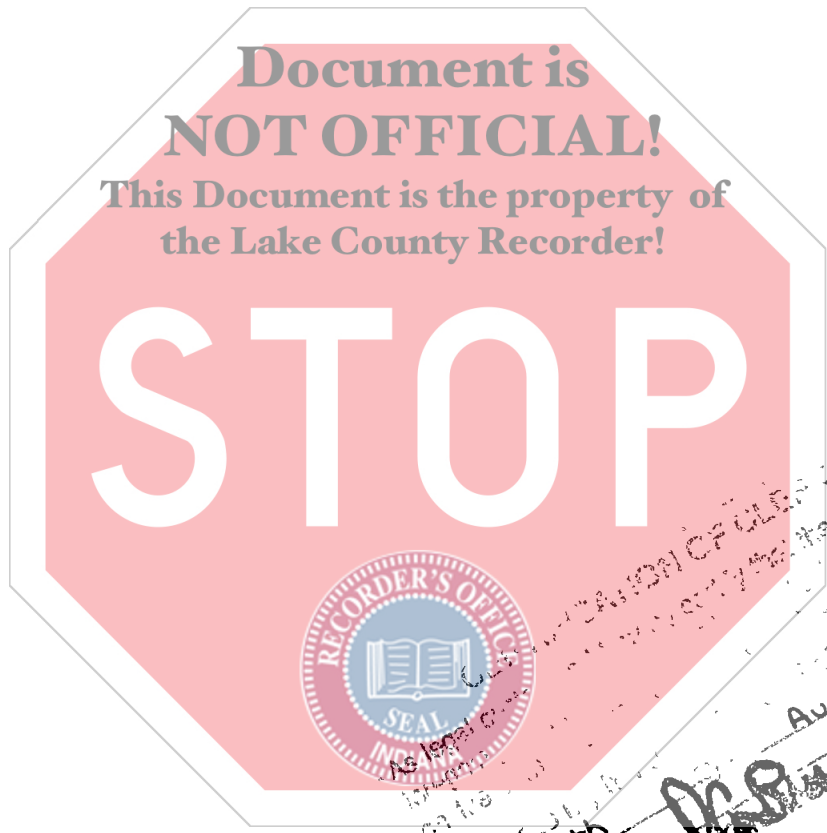
