Lot One (1), Block "F", Meadowland Manor Unit 2, as shown in Plat Book 31, Page 97, in Lake County, Indiana.

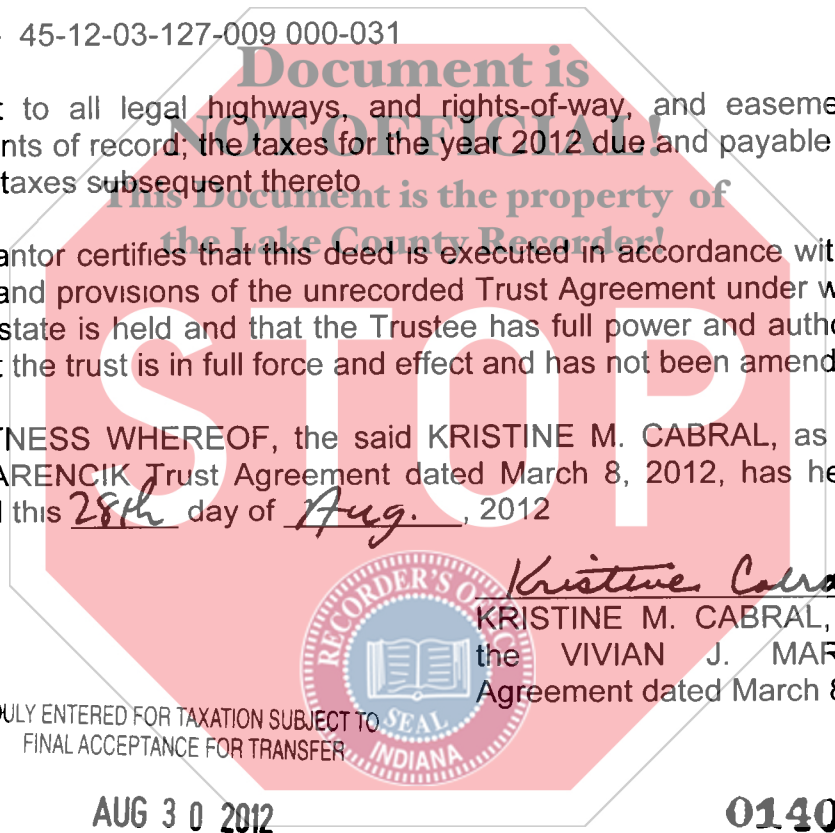

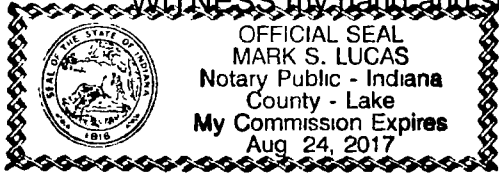
