**AFFIDAVIT OF CORRECTION OF QUITCLAIM DEED**

I, KRISTOPHER KROUSE, being first duly sworn upon my oath, depose and state as follows:

1. I am the Executive Director of Shirley Heinze Land Trust, Incorporated, an Indiana non-profit corporation incorporated under the laws of the State of Indiana on November 1, 2001. Shirley Heinze Land Trust, Incorporated has its principal offices at 444 Barker Road, Michigan City, Indiana 46360. In my capacity as Executive Director of Shirley Heinze Land Trust, Incorporated, I have personal knowledge of the facts set forth herein.

2. On February 2, 2012, the City of Gary, a Municipal Corporation, quitclaimed to "Shirley Heinz (sic) Land Trust" (the "Quitclaim Deed") the following described real estate in the City of Gary, Lake County, State of Indiana:

3. The Quitclaim Deed contained a typographical, clerical error in the name of the Grantee: the Quitclaim Deed spelled the Grantee's name as "Shirley Heinz (sic)

4. A search of the website of the Indiana Secretary of State discloses that there is not and never has been an entity known as “Shirley Heinz Land Trust”. Shirley Heinze Land Trust, Incorporated has always done business under the name “Shirley Heinze Land Trust, Incorporated” and has never been known by any other name since the date of its incorporation on November 1, 2001.

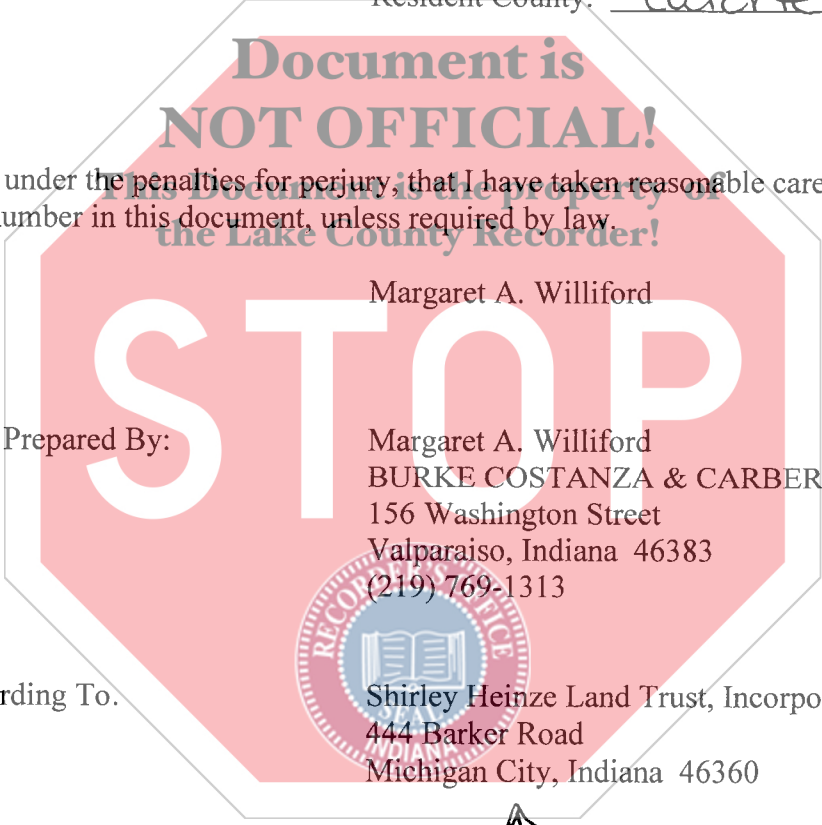
