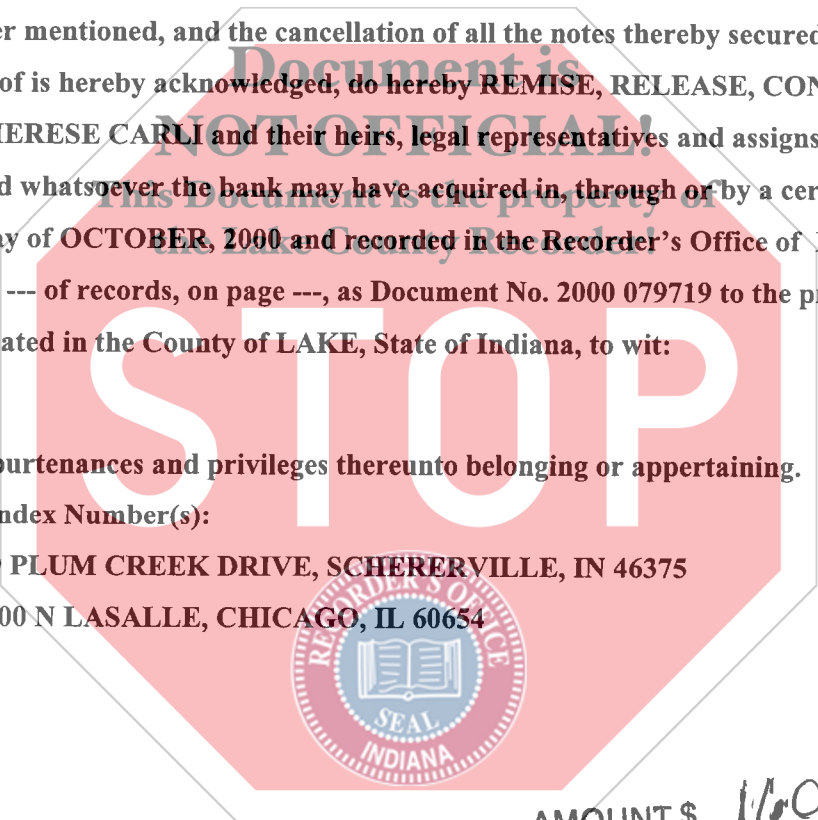

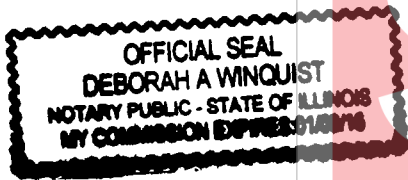

PART OF LOT 4, PLUM CREEK VILLAGE 8TH ADDITION TO THE TOWN OF SCHERERVILLE, INDIANA, AS SHOWN IN PLAT BOOK 64, PAGE 11, IN LAKE COUNTY, INDIANA, SAID LOT 4 DESCRIBED AS FOLLOWS: COMMENCING AT THE WESTERN MOST CORNER OF SAID LOT 4, THENCE NORTHEASTERLY ALONG THE WEST LINE OF SAID LOT 4, TO A CURVE CONCAVE TO THE NORTHWEST AND HAVING A RADIUS OF 550.0 FEET AN ARC DISTANCE OF 48.99 FEET TO THE PLACE OF BEGINNING, THENCE NORTHEASTERLY ALONG THE WEST LINE OF SAID LOT 4, TO A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 550.00 FEET TO AN ARC DISTANCE OF 28.01 FEET, THENCE SOUTHEASTERLY A DISTANCE OF 207.61 FEET TO A POINT ON THE EAST LINE OF SAID LOT 4, A DISTANCE OF 47.74 FEET NORTHERLY OF THE SOUTHEAST CORNER OF SAID LOT 4, THENCE SOUTHERLY ALONG THE EAST LINE OF SAID LOT 4 A DISTANCE OF 33.17 FEET, THENCE NORTHWESTERLY A DISTANCE OF 226.11 FEET TO THE PLACE OF BEGINNING.
