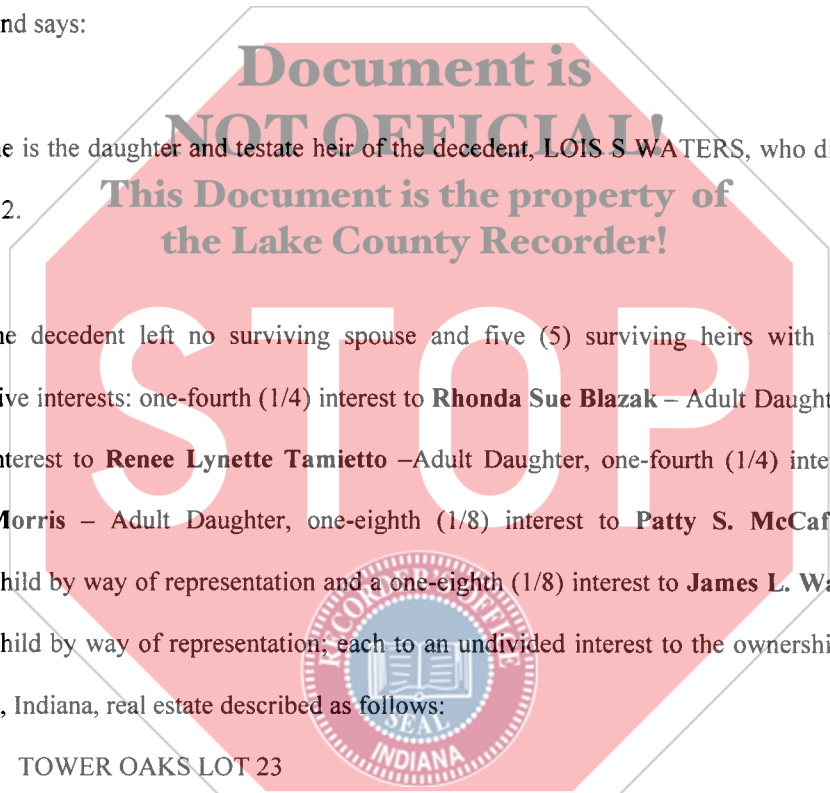
Comes now, Rhonda Sue Blazak, of 3212 W 51st Place, Gary, IN 46408, who being first duly sworn deposes and says:

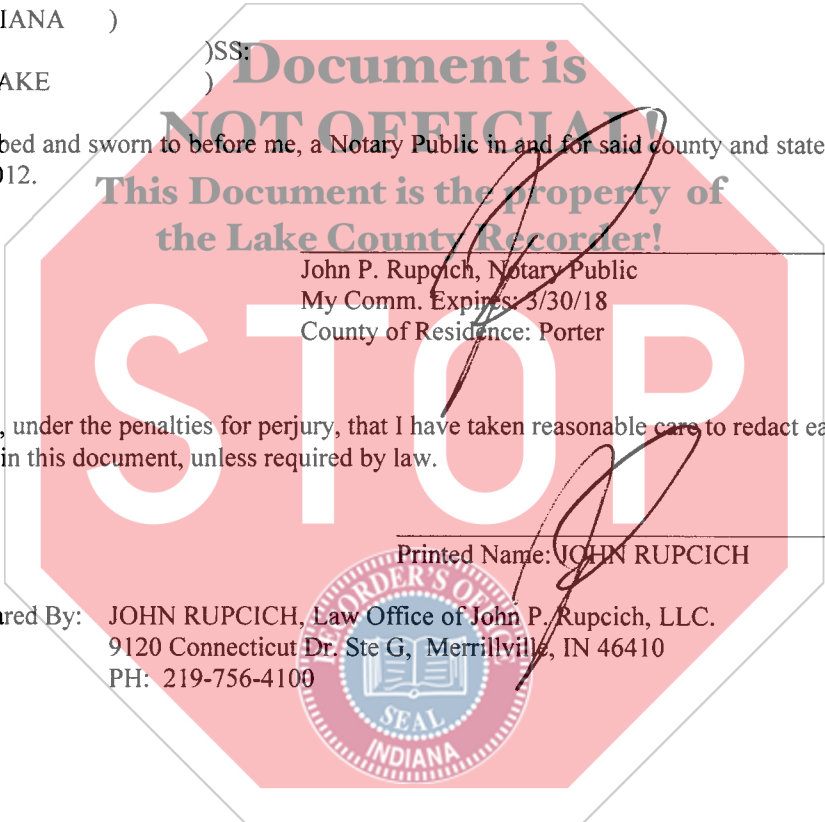
