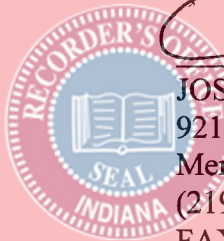

ORDER OF JULY 30, 2008

Antoinette Krupa fka Pwowar, having filed her Verified Petition To Emancipate Child And Determine Support Arrearage, Medical, And College Expenses Due, appears for hearing with counsel, Attorney Joseph S. Irak, on July 30, 2008. Theodore P. Pwowar fails to appear. Parties sworn. Evidence heard. The Court now finds and orders as follows:

1. That proper service by Sheriff was obtained on Theodore P. Pwowar on May 29, 2008.

2. That there currently exists an Order for Respondent to pay to Petitioner the sum of \$118.00 per week for the support of the parties' child.

3. That the child of the parties is no longer attending college and is therefore emancipated as of December 31, 2007.

4. That there currently exists a child support arrearage in the amount of \$3,641.00.

5. That the Respondent is delinquent in his payment to Petitioner for his equal share of uninsured medical costs for services rendered to the parties' child in the amount of \$398.26.

6. That the Respondent is delinquent in his payment to Petitioner for his equal share of college expenses for the parties' child in the amount of \$12,307.32.

7. That a default judgment be entered against the Respondent, Theodore P. Pwowar, in the total amount of \$16,346.58, plus interest at the rate of 8% per annum.

8. That current child support shall terminate as of December 31, 2007.

9. That in lieu of current child support payments which terminated on December 31, 2007, the Respondent is ordered to pay said judgment of \$16,346.58 at the rate of \$118.00 per week, which payments shall be applied to child support arrearage, delinquent medical costs and delinquent college expenses. Respondent is ordered to pay to Petitioner the sum of \$118.00 per week until such time as the delinquent amounts, with accruing interest, have been paid in full.
