all of his right, title and interest in the following described Real Estate in Lake County, Indiana,

The Southwest Quarter of the Southeast Quarter and the South Half of the Southwest Quarter of Section 18, Township 32 North, Range 9 West of the 2<sup>nd</sup> P.M., the Lake County, Indiana, excepting therefrom the following described real estate: Commencing 30 feet West and 30 feet North of the Southeast corner of the Southwest Quarter of the Southeast Quarter of Section 18, Township 32 North, Range 9 West of the 2<sup>nd</sup> Principal Meridian, in Lake County, Indiana, and running thence North along a line parallel to the East line of said Quarter Quarter Section, a distance of 660 feet to a point; thence Westerly along a line parallel to the South line of said Section 18 a distance of 1,320 feet to a point; thence Southerly along a line parallel to the East line of said Quarter Quarter Section to a point 30 feet North of the South line of said Section 18; thence Easterly parallel to the South line of said Section 18 to the point of beginning, containing 20 acres, more or less. 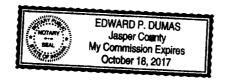
