SPECIAL WARRANTY DEED

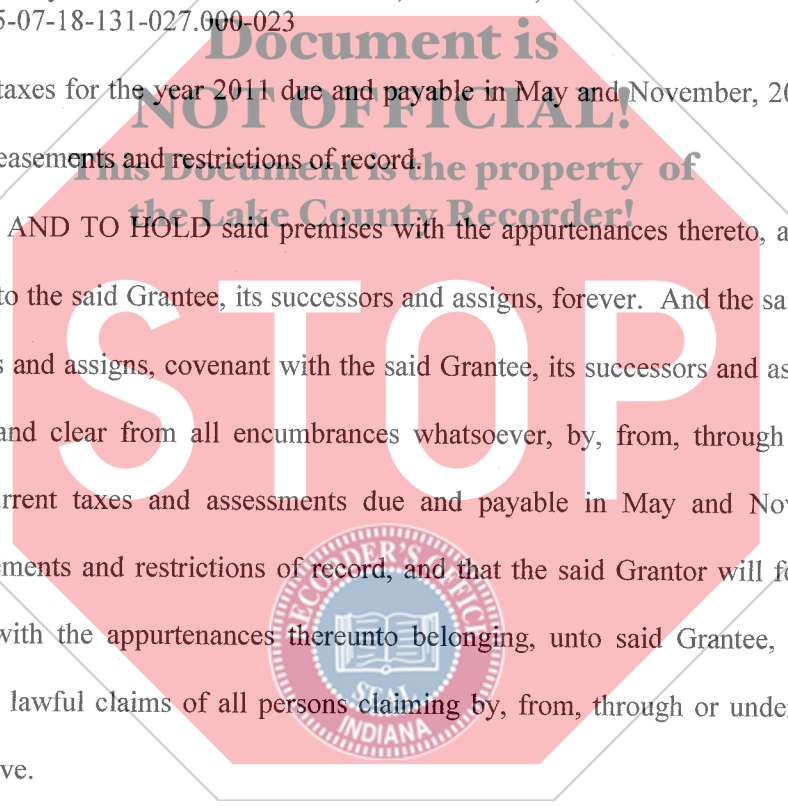

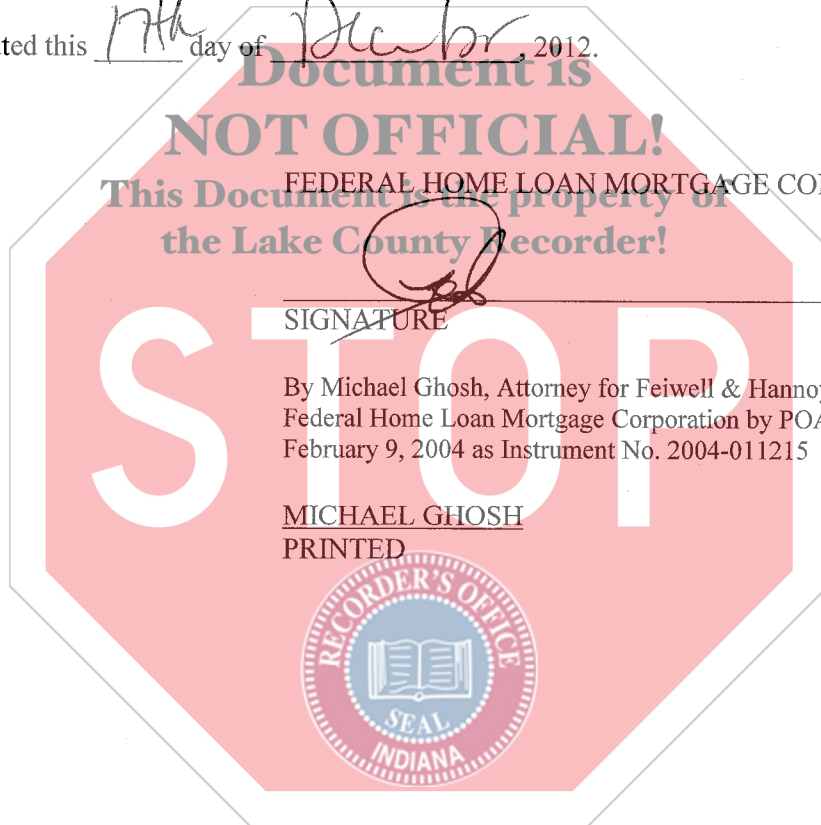

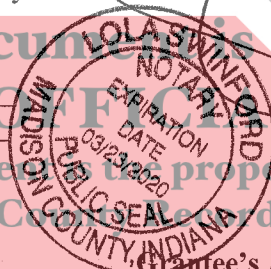
