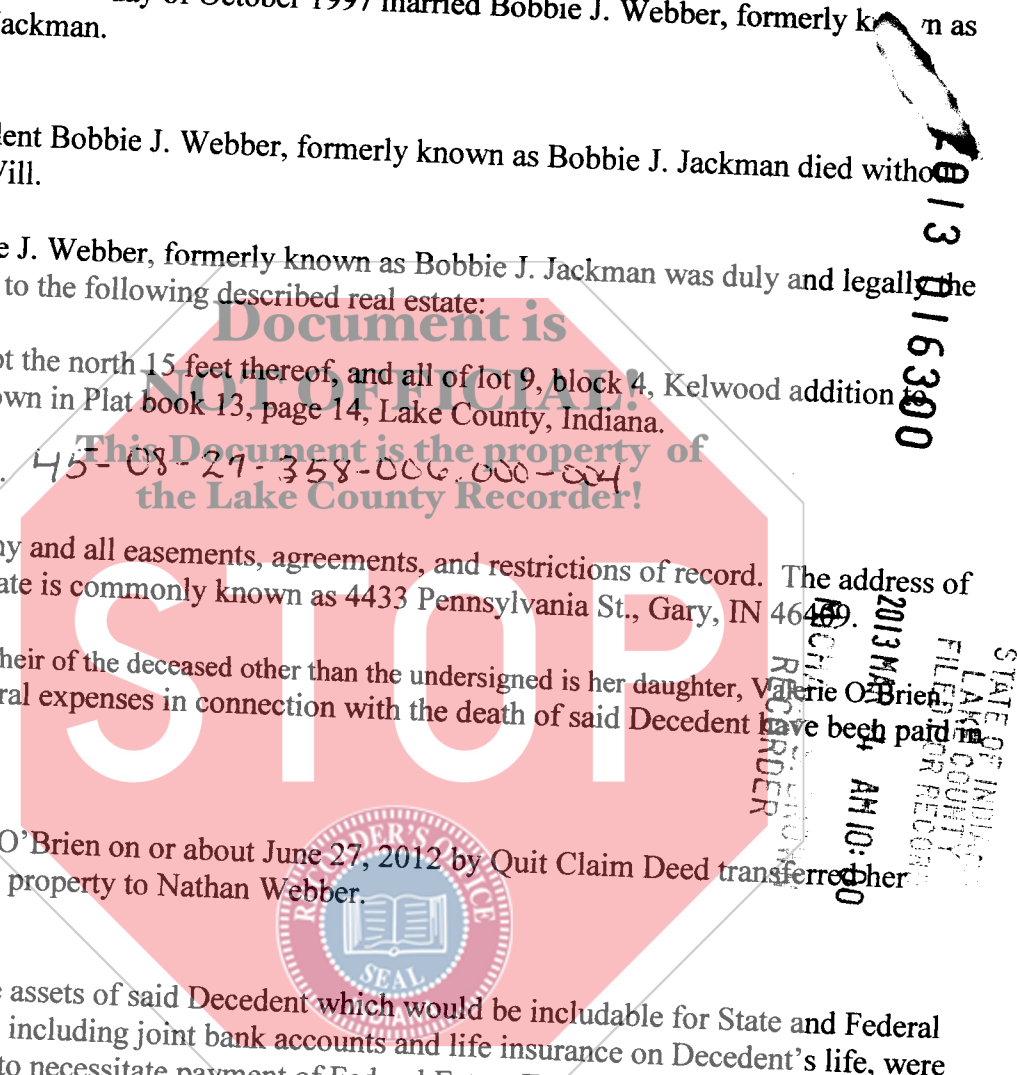


**SURVIVORSHIP AFFIDAVIT**

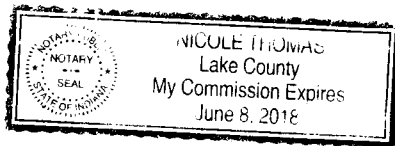
