## **Subordination Agreement**

THIS AGREEMENT is made and entered into on this 13th of February by Wells Fargo Bank N.A. s/b/m Wachovia Mortgage Corporation (hereinafter referred to as "Beneficiary") in favor (Freedom Mortgage Corporation) it's successors and assigns (hereinafter referred to as "Lender").

## WITNESSETHment is

WHEREAS, Wachovia Mortgage Corporation did loan Janice O. Murray and Jack R. Murray (Borrower) the sum of \$15,000 which loan is evidenced by a promissory dated May 17, 2007 executed by Borrower in favor of Wachovia Mortgage Corporation and is secured by a Deed of Trust/Mortgage even date therewith (the "Second Loan") covering the property described therein and recorded as Instrument Number 2007077458 Libor n/a page n/a and of the real property records in the office of Lake County, State of Indiana and

WHEREAS, Borrower has requested that Lender lend to it the sum of \$110,966 (not to exceed), such loan to be evidenced by the promissory note dated rebivally 21, 2013 executed by Borrower in favor of Lender and secured by a Mortgage of even date therewith (the "New Mortgage") covering in whole or in part of the property covered by the Mortgage: and

NOW, THEREFORE, in consideration of One Dollar and in consideration for the premises and for other good and valuable consideration, the receipt and sufficiency all of which is hereby acknowledged, and in order to induce Lender to make the Loan above referred to, Beneficiary agrees as follows:

- 1. The New Mortgage and the note secured thereby and the debt evidenced by such and any and all renewals and interest payable on all of said debt and on any and all such renewals and extensions shall be and retain at all times a lien or charge on the property covered by the New Mortgage, prior and superior to the lien or charge of the Mortgage in favor of Beneficiary.
- 2. <u>Beneficiary</u> acknowledges that it intentionally waives, relinquishes, and subordinates the priority and superiority of the lien or charge of the Mortgage in favor of the lien or charge of the New Mortgage in favor of <u>Lender</u> and that it understands that in reliance upon and in consideration of this waiver, relinquishment, and subordination specific loans and advances are being and will be made, and as part and parcel thereof specific monetary and other obligations are being and will be entered into by <u>Lender</u> which would not be made or entered into but for such reliance upon this waiver, relinquishment, and subordination.
- 3. This agreement contains the entire agreement between the parties hereto as to the loan secured by the Mortgage and the Loan secured by the New Mortgage, and the priority thereof, and there are no agreements, written or oral, outside or separate from this agreement and all prior negotiations are merged into this agreement.
