
**SUBORDINATION AGREEMENT**

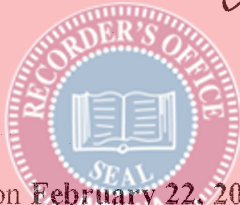


