THE CONDITION OF THE ABOVE OBLIGATION IS SUCH that whereas the said Principal has been granted a CONTRACTORS LICENSE

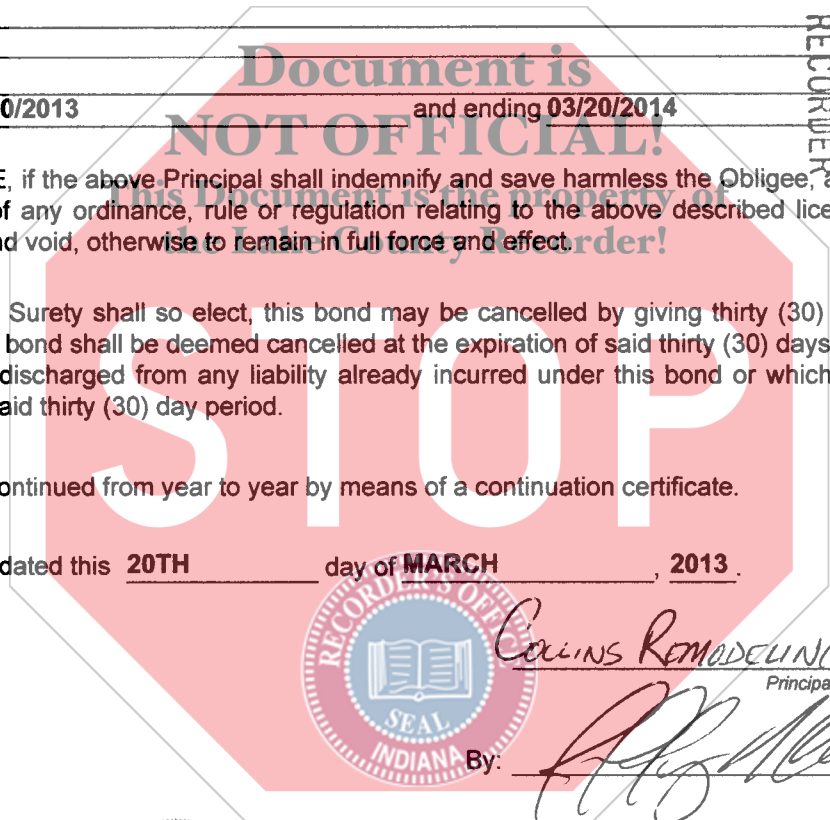
for a term beginning 03/20/2013 and ending 03/20/2014

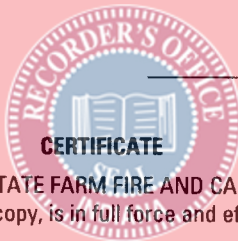
