SPECIAL WARRANTY DEED

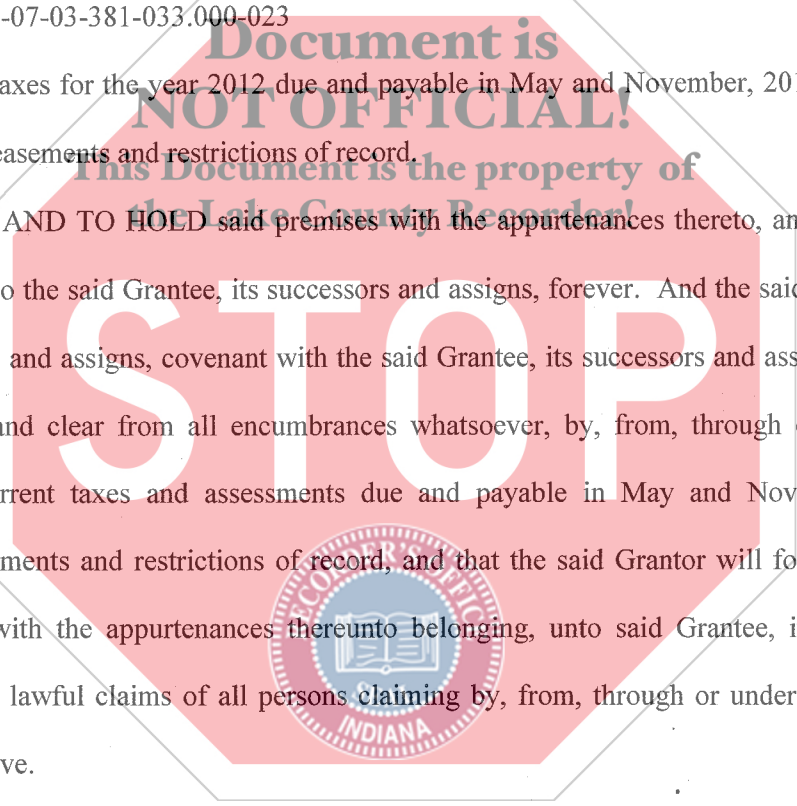

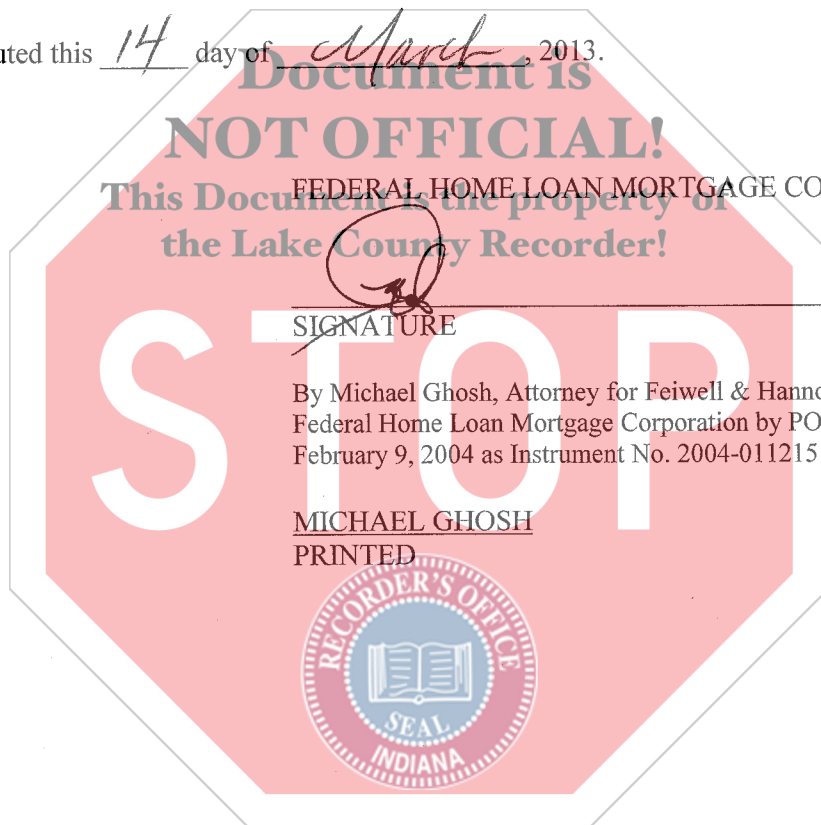

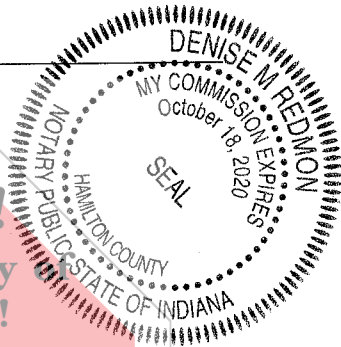
