SPECIAL WARRANTY DEED

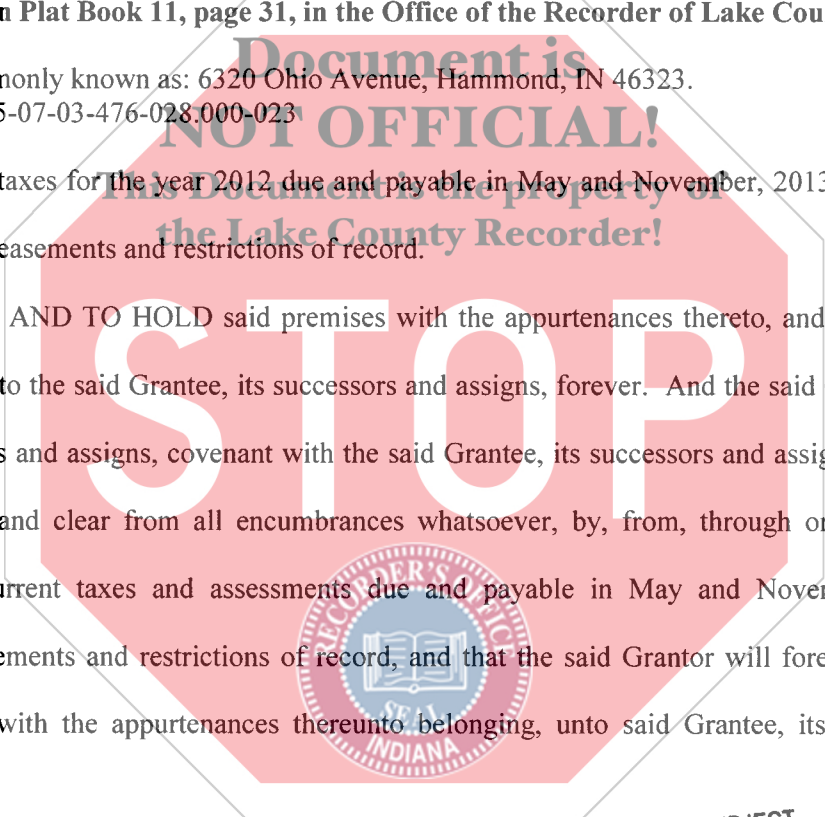
